**Resolution authorizing Tax Collector Attorney to file suit against responsible relative to recover value of services rendered at hospital facilities operated by the San Francisco Department of Public Health.**

WHEREAS, It appears from the San Francisco Treasurer and Tax Collector's letter dated October 25, 2007, identifying those recipients of medical aid at San Francisco medical facilities who have relatives legally liable for the cost of medical treatment rendered to their kindred, which letter is on file with the Clerk of the Board of Supervisors in File No. 071553; and

WHEREAS, It further appears that the Tax Collector has determined that each of the below-named relatives has the financial ability to pay for the aid rendered to their kindred at San Francisco Department of Public Health at the time the aid was rendered and at the present time; now, therefore, be it

RESOLVED, That the Tax Collector Attorney be, and hereby is, authorized and directed to institute legal proceedings against the herein named relative deemed responsible for the payment for said medical services, and to seek recovery in full of charges for medical aid rendered at San Francisco Department of Public Health medical facilities pursuant to Section 17300 of the California Welfare and Institutions Code.




