Resolution extending by 30 days the prescribed time within which the Planning Commission may render its decision on a proposed Ordinance that would amend Planning Code Sections 725.1 and 725.42 of the Union Street Neighborhood Commercial District to provide for a limited number of new full service restaurants that satisfy specific requirements and obtain conditional use authorization; and making environmental findings and findings of consistence with the General Plan and priority policies of Planning Code Section 101.1.

WHEREAS, On October 16, 2007, Supervisor Alioto-Pier introduced legislation to initiate the process amending San Francisco Planning Code Sections 725.1 and 725.42 of the Union Street Neighborhood Commercial District to permit up to 10 new full service restaurants that satisfy specific requirements and obtain conditional use authorization, and making findings, including environmental findings and findings of consistency with the priority policies of Planning Code Section 101.1 and the General Plan. A copy of said legislation is on file with the Clerk of the Board of Supervisors in File No. 071425 and is incorporated herein by reference; and,

WHEREAS, On or about October 25, 2007, the Clerk of the Board of Supervisors referred the proposed ordinance to the Planning Commission, which currently is reviewing the proposed ordinance; and,

WHEREAS, The Board, in accordance with Planning Code Section 306.4(d) may, by resolution, extend the prescribed time within which the Planning Commission is to render its decision on proposed amendments to the Planning Code that the Board of Supervisors initiates; and,
