Resolution authorizing the Mayor's Office of Criminal Justice (MOCJ) to retroactively accept and expend a grant in the amount of \$137,989 from the United States Department of Justice (DOJ), Bureau of Justice Assistance (BJA), under the Bulletproof Vest Partnership Program to purchase armor vests for law enforcement officers in the Sheriff's Department, Police Department, Office of the District Attorney, Juvenile Probation Department and Adult Probation Department.

WHEREAS, MOCJ is the lead fiscal agency in administering the Bullet Proof Vest Partnership Grant; and

WHEREAS, The Bulletproof Vest Partnership Grant Act provides money to be administered by the U.S. Department of Justice, to protect the lives of law enforcement officers by helping states, units of local government and tribal governments to equip their law enforcement officers with armor vests; and

WHEREAS, The Bulletproof Vest Partnership Grant Act directs the Bureau of Justice Assistance, Department of Justice, to award money on a need basis to purchase vests; and

WHEREAS, In adherence to the Department of Justice requirements that the applicant of each eligible jurisdiction coordinate vests needs among the law enforcement agencies in their jurisdiction that apply; and

WHEREAS, The Federal grant requires a fifty percent local contribution toward (i.e., match of) each jurisdiction's total costs of eligible vest purchases; and

WHEREAS, Because the entire award by the Department of Justice's Bulletproof Vest Partnership Grant Act funds direct purchases of vests, it is requested that indirect costs be waived; and

Page 1 11/14/2007 WHEREAS, The Sheriff, Police, District Attorney, Juvenile and Adult Probation Departments have budgeted FY07 general funds for the purchase of Bulletproof Vests as matching funds; and

WHEREAS, The Bulletproof Vest Partnership Grant Act considers as eligible for funding any vests purchased on or after January 1, 2004 regardless of the federal fiscal year of the grant; and

WHEREAS, Under the Bulletproof Vest Partnership Act, the City and County of San Francisco was awarded a supplemental funding grant of \$137,989 for Federal FY2007 to pay 50% cost of purchasing bulletproof vests; and

WHEREAS, The grant terms prohibit including indirect costs in the grant budget; and WHEREAS, The grant does not require and ASO amendment; and

RESOLVED, That MOCJ will be responsible for the fiscal, programmatic and administrative reporting to the Bureau of Justice Assistance; now, therefore, be it

FURTHER RESOLVED, That the City and County of San Francisco hereby authorizes MOCJ to retroactively accept and expend \$137,989 from the Department of Justice, to administer the Bulletproof Vest Program.
