Resolution approving an extension on the deadline for the annual report to the Board of Supervisors on all community safety cameras located in the City and County of San Francisco from January 17, 2008 to March 20, 2008, one year from the date of installation of the cameras.

WHEREAS, The Board of Supervisors added Chapter 19 to the San Francisco Administrative Code, also known as the Community Safety Camera Ordinance; and

WHEREAS, The Community Safety Camera Ordinance mandates an annual report to the Board of Supervisors and the Police Commission regarding the efficacy of all community safety cameras located in the City and County of San Francisco; and,

WHEREAS, The Community Safety Ordinance mandates the report be issued one year from approval of camera installation; and,

WHEREAS, The Police Commission indicated an intent to have a full year of data on the efficacy of the community safety cameras from the date of initial operation; and,

WHEREAS, The installation of the community safety cameras in fact occurred in March 2007; and,

WHEREAS, The Center for Information Technology Research in the Interest of Society at U.C. Berkeley is performing a study on the efficacy of the surveillance cameras that will assist production of the annual report by March 20, 2008; now, therefore, be it

RESOLVED, That the Police Department, in conjunction with the City Administrator, shall issue the annual report to the Board of Supervisors and Police Commission one year following the date of the first camera installation and not less often than once yearly thereafter; and, be it
