Resolution authorizing the Public Health Department to accept a gift of a Data Center and an Electronic Medication Administration Record System for the San Francisco General Hospital (SFGH) from the San Francisco Hospital Foundation (SFGH Foundation)

WHEREAS, the Department of Public Health's (DPH) Information Systems Department currently operates and maintains 120 servers which support the direct patient care activities of the staff at San Francisco General Hospital (SFGH); and

WHEREAS, the demand for additional clinical systems exceeds the capacity of the current data center and software upgrades for patient care related functions cannot be installed due to insufficient server capacity; and

WHEREAS, DPH can not expand existing space due to lack of supply, insufficient funding and the inability to co-locate servers due to requirements that critical care systems be on site; and

WHEREAS, the best solution is a mobile data center; and

WHEREAS, SFGH is converting the existing medication administration system to a completely electronic system that will provide real time documentation capabilities and enable better clinical decision making and more accurate communication between

Public Health BOARD OF SUPERVISORS providers, nursing and pharmacy staff and minimize medication errors; and

WHEREAS, a software product is available that is compatible with SFGH's Pharmacy software and it will eliminate the need for the nursing staff to transcribe provider orders by hand; and

WHEREAS, the Gordon and Betty Moore Foundation has given the SFGH Foundation a gift of \$2,262,000 for purchase and installation of a data center and an eMAR product for SFGH; and

WHEREAS, DPH wishes to obtain approval from the Health Commission and the Board of Supervisors to accept a gift of a data center and an Electronic Medication Administration Record System for the San Francisco General Hospital from the the San Francisco General Hospital Foundation; and now, therefore; be it

RESOLVED, that the Department of Public Health, is hereby authorized to accept this gift in accordance with the requirements set forth pursuant to San Francisco Administrative Code Section 10.100-305, and Code Section 10.100-201; and, be it

FURTHER RESOLVED, that the Department of Public Health is hereby authorized to accept a gift of a data center and an Electronic Medication Administration Record System for the San Francisco General Hospital from the San Francisco General Hospital Foundation
