[Liquor License – Pier 39, Space N213A]

Resolution determining that the issuance of a Type 42 on-sale beer and wine public premises license to Tiffany M. Pisoni for Wines of California wine bar, located at Pier 39, Space N213A (District 3), will serve the public convenience and necessity of the people of the City and County of San Francisco, in accordance with Section 23958.4 of the California Business and Professions Code, with conditions.

WHEREAS, Tiffany M. Pisoni is seeking the issuance of a Type 42 on-sale beer and wine public premises license for Wines of California wine bar, located at Pier 39, Space N213A (District 3); and,

WHEREAS, The Planning Department has verified that the area is properly zoned; and,

WHEREAS, The Police Department recommends that the liquor license application be approved with conditions; now, therefore, be it

RESOLVED, That in accordance with Section 23958.4 of the California Business and Professions Code, the Board of Supervisors of the City and County of San Francisco hereby determines for the foregoing reasons that the issuance of a Type 42 on-sale beer and wine public premises license to Tiffany M. Pisoni for Wines of California wine bar, located at Pier 39, Space N213A, will serve the public convenience and necessity of the people of the City and County of San Francisco.

Conditions: (1) The sales, service, and consumption of alcoholic beverages shall be permitted only between the hours of 11:00 a.m. and 10:00 p.m. each day of the week. (2) No noise shall be audible beyond the area under the control of the

City Operations and Neighborhood Services Committee BOARD OF SUPERVISORS licensee(s). (3) No person under the age of twenty-one (21 years of age) shall sell, furnish, or deliver alcoholic beverages. (4) There shall be no coin operated games or video machines maintained upon the premises at any time. (5) Loitering (loitering is defined as "to stand idly about; linger aimlessly without lawful business") is prohibited on any sidewalks or property adjacent to the licensed premises under the control of the licensee. (6) The petitioners shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control. (7) Graffiti shall be removed from the premises and all parking lots under the control of the licensee within 72 hours of application. If the graffiti occurs on a Friday or weekend day, or on a holiday, the licensee shall remove the graffiti within 72 hours following the beginning of the next weekday. (8) The interior lighting maintained therein shall be sufficient to make easily discernible the appearance and conduct of all persons and patrons in that portion of the premises where alcoholic beverages are sold, served, delivered or consumed. (9) The exterior of the premises shall be equipped with lighting of sufficient power to illuminate and make easily discernible the appearance and conduct of all persons on or about the premises. Additionally, the position of such lighting shall not disturb the normal privacy and use of any neighboring residences. (10) No person under the age of 21 shall enter or remain in these public premises.
