[Urging Congress to hold hearings on HR 676]

Resolution urging the United States House of Representatives to begin hearings on House Resolution 676 – The United States National Health Insurance Act (Expanded and Improved Medicare for All) authored by Representative John Conyers, Jr. (D - MI).

WHEREAS, United States Representative, John Conyers, Jr. (D - MI), has introduced House Resolution 676, the United States National Health Insurance Act, in the United States House of Representatives for the 110<sup>th</sup> Congress, and this act would provide a universal, comprehensive, single payer system of high quality national health insurance; and,

WHEREAS, Rationing healthcare according to ability to pay has diminished the overall health of our citizens to the point at which the United Sates ranks shamefully low at thirty-seventh in quality by the World Health Organization; and,

WHEREAS, Approximately 80,000 San Franciscans lacked health insurance in 2007, and every person in San Francisco and in the United States deserves access to affordable quality healthcare; and,

WHEREAS, HR 676 will cover all medically necessary services, including primary care, in-patient care, out-patient care, emergency care, prescription drugs, durable medical equipment, hearing services, long-term care, mental health services, dentistry, eye care, chiropractic, and substance abuse treatment; and,

WHEREAS, The Institute of Medicine has estimated that 18,000 people a year die because of lack of health insurance; and,

WHEREAS, Those insured now often experience burdensome medical debt and sometimes life-threatening delays in obtaining healthcare; and,

WHEREAS, One-half of personal bankruptcies are due to illness or medical bills; and,

WHEREAS, HR 676 allows patients to have their choice of physicians, providers, hospitals, clinics, and practices; and,

WHEREAS, No co-pays or deductibles are permissible under 676; and,

WHEREAS, The crisis in healthcare in the United States of America includes rising health costs, increased costs and out-of-pocket medical expenses; and,

WHEREAS, The rising cost of insuring public employees can be reduced and best met not by limiting benefits but by providing benefits under a publicly-funded health insurance program; and,

WHEREAS, The complex bureaucracy arising from a fragmented, multi-payer system of healthcare financing consumes approximately 30 percent of U.S. healthcare spending; now therefore be it

RESOLVED, That the City and County of San Francisco endorse House Resolution 676; and, be it

FURTHER RESOLVED, That the City and County of San Francisco call upon the United States House of Representatives to begin hearings on House Resolution 676 as soon as possible; and, be it

FURTHER RESOLVED, That the Board of Supervisors direct the Clerk of the Board to send this resolution to our Federal Legislative Delegation.
