Resolution urging a Federal Employment Non-Discrimination Act that includes gender identity protections.

WHEREAS, In 2007 President Bush pledged to veto the Employment Non Discrimination Act (ENDA) with or without gender identity; and

WHEREAS, over 350 national, state, and local LGBT organizations have signed a letter stating that they supported a fully inclusive ENDA and opposed any legislation that leaves anyone behind, while also requesting the Congressional leadership to only introduce a version of ENDA that includes gender identity in their next session; and

WHEREAS, The Human Rights Campaign (HRC) supported a non-inclusive ENDA in the last congressional session, without dialogue and discussion with other national LGBT Civil Rights organizations, such as the National Gay and Lesbian Task Force (NGLTF) and the National Center for Lesbian Rights (NCLR);and

WHEREAS, The withdrawal of employment protection for individuals based upon gender identity caused tremendous pain for Transgendered persons throughout the United States who felt discarded and marginalized; and

WHEREAS, The opportunity exists to unite the LGBT community and advocates for employment non-discrimination by pursuing an ENDA in the 111th Congress that includes protections for gender identity; and

WHEREAS, It should be the goal to create meaningful employment non-discrimination legislation that addresses the pervasive and damaging discrimination faced by Transgendered Americans in the workplace; now, therefore, be it,

FURTHER RESOLVED, That the San Francisco Board of Supervisors urges all local, state, and national Democratic organizations and elected officials to protect lesbians, gay men, bisexuals and transgender people from discrimination by ensuring that a fully inclusive ENDA is introduced, thereby closing a gap and loophole in the existing version of ENDA that bans only sexual orientation discrimination; and, be it

FURTHER RESOLVED, That the San Francisco Board of Supervisors recognizes that many members of San Francisco's LGBT Community and elected officials will forgo attending the 2008 Human Rights Campaign Dinner in San Francisco to express disagreement with a strategy that would remove gender identity protections from employment non-discrimination legislation; and

FURTHER RESOLVED, That the Clerk of the Board is requested to send this resolution to the Human Rights Campaign and Members of our local State and Federal elected family urging that every step be taken to ensure that gender identity protection is included in ENDA as it is considered by the 111th Congress
