Resolution urging the California State Legislature to fully fund Proposition 42 as proposed by the Governor in the Fiscal Year 2008-09 California State Budget and supported by the Budget Conference Committee.

[Supporting full funding of Proposition 42 in the FY 2008-09 California State Budget.]

WHEREAS, Proposition 42 mandates that the state gasoline sales tax be earmarked for transportation; and,

WHEREAS, Proposition 1A, enacted by the voters of California in 2006, fully dedicated the state gasoline sales tax to transit and transit improvements by limiting the number of times that this funding source could be diverted by the Governor and Legislature in times of fiscal crisis; and,

WHEREAS, California's Cities and Counties rely on funds from Proposition 42 to provide vital maintenance and rehabilitation on local streets and roads as well as public transportation services; and,

WHEREAS, The January release and May revision of the Governor's Fiscal Year 2008-09 budget included approximately \$1.4 billion in revenue from the state gasoline sales tax for Proposition 42; and,

WHEREAS, The budget proposed by the Budget Conference Committee does not contain provisions suspending Proposition 42; and,

WHEREAS, San Francisco's Department of Public Works (SFDPW) anticipates receipt of \$11.7 million to fund street resurfacing improvements on 106 street segments; and,

WHEREAS, The Municipal Transportation Agency (SFMTA) has budgeted its portion of Proposition 42 funding that will flow through the State Transit Assistance formula to critical transit operations improvements; and,

WHEREAS, A postponement of Proposition 42 will lead to further degradation of the City's local street network and delay improvements in Muni's transit route system; now, therefore be it

RESOLVED, That the City and County hereby supports the transportation funding recommendations of the Governor and Budget Conference Committee to fully fund Proposition 42.
