Resolution urging the San Francisco Municipal Transportation Agency Board of Directors to increase the fine for first time fare evasion from \$50 to \$75 and increase the fine for second time fare evaders to \$250 and increase the fine for third time fare evaders to \$500

WHEREAS, The San Francisco Municipal Transportation Agency (SFMTA) oversees the Municipal Railway (Muni), which has close to 700,000 boardings each day; and

WHEREAS, Muni depends on a variety of sources to fund its operations, including local, state and federal revenue sources as well as fare revenue from its riders; and

WHEREAS, San Francisco has had historically low fares compared to similar-sized transit agencies in the United States; and

WHEREAS, As a result of low fares and fare evasion only approximately 22 percent of Muni's operating revenue comes from fares; and

WHEREAS, Fare evasion represents a breach of the public trust requiring that all users of the Muni system should pay their fare to keep the system running; and

WHEREAS, In February 2008 the SFMTA implemented a state law that had been supported by the SFMTA in Sacramento allowing adult fare evasion citations to be handled administratively rather than in the criminal justice system, where SFMTA did not have control over the process or the revenue; and

WHEREAS, The fine for fare evasion should be high enough to deter such behavior and make sure that people pay their fares; and

WHEREAS, Under the Charter, setting the fine for fare evasion is under the jurisdiction of the SFMTA Board of Directors; now, therefore, be it
