4 **Resolution authorizing the San Francisco Planning Department to apply for funds from**
5 **the State of California Clean Water State Revolving Fund for streetscape, traffic**
6 **calming, and green stormwater improvements along the 1700 Block of Newcomb**
7 **Avenue.**

9 WHEREAS, The California State Water Resources Control Board (SWRCB) issued a
10 call for projects to be funded by the Clean Water State Revolving Fund; and

11 WHEREAS, The Clean Water State Revolving Fund received funds from the American
12 Recovery and Reinvestment Act (ARRA) of 2009; and

13 WHEREAS, The Association of Bay Area Government (ABAG) issued a call for
14 greening projects within areas designated as Priority Development Areas; and

15 WHEREAS, The San Francisco Planning Department and the Mayor's Office of City
16 Greening jointly submitted the Newcomb Avenue Model Block Streetscape Improvements
17 ("Newcomb Project") for consideration by ABAG; and

18 WHEREAS, The Newcomb Project includes corner plazas, green stormwater elements,
19 street trees, and traffic calming measures; and

20 WHEREAS, The Newcomb Project includes significant stormwater volume and flow
21 reduction methodologies; and

22 WHEREAS, The City and County of San Francisco has received a grant from the
23 United States Environmental Protection Agency (USEPA) in the amount of \$492,500 to help
24 fund the Newcomb Project; and

1 WHEREAS, The Newcomb Project received two City and County of San Francisco
2 Community Challenge Grants for a total amount of \$158,921; and

3 WHEREAS, the Newcomb Project has a funding gap in the amount of \$707,500; and

4 WHEREAS, the San Francisco Planning Department requested \$707,500 in grant
5 funds from the SWRCB; and

6 WHEREAS, ABAG selected the Newcomb Project for inclusion in an application to the
7 SWRCB; and

8 WHEREAS, The SWRCB selected the projects included in the ABAG application for
9 inclusion in the Board's Priority List; and

10 WHEREAS, The City and County of San Francisco has a Transit First policy; and

11 WHEREAS, The City and County of San Francisco has a Complete Streets Ordinance;
12 and

13 WHEREAS, The policies and goals of the City and County of San Francisco are
14 advanced by the Newcomb Project; and

15 WHEREAS, The Newcomb Project has received California Environmental Quality Act
16 clearance; and

17 WHEREAS, The Newcomb Project has received all discretionary approvals; now,
18 therefore, be it

19 RESOLVED, That the Director of the Planning Department, or a designee, is hereby
20 authorized and empowered to execute in the name of the City and County of San Francisco a
21 Financial Assistance Application for a financing agreement from the State Water Resources
22 Control Board for the planning, design, and construction of the Newcomb Project, as well as
23 all other necessary applications, contracts, payment requests, agreements and amendments
24 hereto for the purpose of securing grant funds and to implement and carry out the purposes
25 specified in the grant application; and be it
