WHEREAS, DPH was awarded a grant from the University of Miami in the amount of \$122,160 for a project entitled HIV Testing and Counseling in STD Clinics; for the period of September 30, 2009 through September 29, 2011; and,

WHEREAS, The purpose of this grant is to perform a randomized controlled clinical trial comparing the relative efficacy and cost-effectiveness of two HIV testing strategies: (1) on-site HIV rapid testing with brief, participant-tailored prevention counseling (based on Project Respect) versus (2) on-site HIV rapid testing with information only (as recommended in the Centers for Disease Control guidelines); and,

WHEREAS, The grant does not require an ASO amendment and reimburses DPH for one existing position: one Senior Physician Specialist, (Job Class 2232) at 0.20 FTE for the period from September 30, 2009 through September 29, 2011; and,

WHEREAS, The grant budget includes a provision for indirect costs in the amount of \$24,299; now, therefore, be it

RESOLVED, That DPH is hereby authorized to accept and expend a grant in the amount of \$122,160 from the University of Miami; and, be it

FURTHER RESOLVED, That the Controller is directed to designate the positions funded under this agreement as a "G" or grant-funded position which would terminate when the agreement expires; and, b'it

FURTHER RESOLVED, That the Director of Health is authorized to enter into the agreement on behalf of the City.
