Supervisor Dufty BOARD OF SUPERVISORS FURTHER RESOLVED, that the San Francisco Police Department, at its own expense, agrees to the costs of ownership and maintenance over the life of the vehicles; and be it

FURTHER RESOLVED, that it is agreed that any liability arising out of the performance of this Grant Award Agreement, including civil court actions for damages, shall be the responsibility of the City and the San Francisco Police Department.
