

1 [ARRA Project - Award of Contract for LRV Systems Overhaul.]

3 **Resolution authorizing the San Francisco Municipal Transportation Agency to enter**  
4 **into Contract No. APT 591-01, LRV Doors and Steps Reconditioning and Systems**  
5 **Overhaul, with AnsaldoBreda Inc., in an amount not to exceed \$56,752,554 and a term**  
6 **not to exceed five years.**

8 WHEREAS, On February 17, 2009, President Obama signed into law the American  
9 Recovery and Reinvestment Act of 2009 (ARRA), landmark legislation aimed at addressing  
10 the nation's crucial infrastructure needs and creating jobs in the process; and

11 WHEREAS, The Federal Transit Administration announced that the San Francisco  
12 Municipal Transportation Agency ("SFMTA") will receive \$67.2 million to complete critical  
13 fleet, infrastructure and facilities rehabilitation and improvement projects; and

14 WHEREAS, In order to receive the ARRA funds, strict, non-negotiable timelines must  
15 be honored; specifically, the Metropolitan Transportation Commission has mandated that all  
16 ARRA-funded contracts be awarded by no later than November 30, 2009, or the funds will be  
17 withdrawn and reallocated to other transit agencies; and

18 WHEREAS, Contract No. APT 591-01, LRV Doors and Steps Reconditioning and  
19 Systems Rehabilitation, is for rehabilitation of key operating systems on the existing fleet of  
20 light rail vehicles, which will improve the reliability of the fleet; and

21 WHEREAS, The scope of work under Contract No. APT 591-01 will include all labor,  
22 inspections, engineering, tools, materials, parts, facilities and equipment required to complete  
23 all work, including all required detailed drawings, design calculations and other specified  
24 technical documentation in connection with the rehabilitation of these systems; and

1           WHEREAS, On May 6, 2009, the SFMTA issued a Request for Proposals (RFP) for the  
2 project; the SFMTA received one proposal from AnsaldoBreda Inc., 1461 Loveridge Road,  
3 Pittsburg, CA 94565, in response to the RFP; and

4           WHEREAS, On September 15, 2009, the SFMTA Board of Directors adopted  
5 Resolution No. 09-     , which authorized the Executive Director/CEO to execute Contract No.  
6 APT 591-01 with AnsaldoBreda Inc. for an amount not to exceed \$56,752,554 and for a term  
7 not to exceed five years, a copy of which contract is on file with the Clerk of the Board of  
8 Supervisors in File No. 091109     , which is declared to be a part of this motion as if set forth  
9 fully herein; and,

10          WHEREAS, Section 9.118 of the City Charter requires approval of the Board of  
11 Supervisors by resolution of contracts entered into by the City and County requiring  
12 anticipated expenditures of ten million dollars or more; now, therefore, be it

13          RESOLVED, That the Board of Supervisors authorizes the SFMTA to enter into  
14 Contract No. APT 591-01, LRV Doors and Steps Reconditioning and Systems Rehabilitation,  
15 with AnsaldoBreda Inc., for an amount not to exceed \$56,752,554 and for a term not to  
16 exceed five years.
