

1 [Emergency contract to replace main sewer on California Street from Cherry Street to Arguello
2 Boulevard.]

3 **Resolution approving an emergency public work contract under San Francisco**
4 **Administrative Code Section 6.60 to replace the main sewer on California Street from**
5 **Cherry Street to Arguello Boulevard.**

7 WHEREAS, On May 6, 2009 a sewer inspection performed by San Francisco Public
8 Utilities Commission personnel discovered approximately 70 feet of collapsed sewer main on
9 California Street from Cherry Street and Arguello Boulevard, as well as cracks in the sewer
10 crown;

11 WHEREAS, To protect the public's health and safety, the collapsed sewer needs to be
12 replaced and immediately returned to service; and

13 WHEREAS, San Francisco Administrative Code, Chapter 6, Article IV, section 6.60,
14 authorizes department heads responsible for public work to award an emergency contract,
15 exempt from the competitive bidding process, in the event of an actual emergency which
16 includes, ". . . The breakdown or imminent breakdown of any plant, equipment, structure,
17 street or public work necessitating immediate emergency repair or reconditioning to safeguard
18 the lives or property of the citizens; or the property of the City and County; or to maintain the
19 public health or welfare;" and

20 WHEREAS, On May 6, 2009, the General Manager declared an emergency, approved
21 by the President of the San Francisco Public Utilities Commission, to replace the main sewer
22 on California Street from Cherry Street to Arguello Boulevard and thereby protect public
23 health and safety; and

24 WHEREAS, Section 6.60(D) requires that the San Francisco Board of Supervisors
25 approve an emergency with an estimated cost in excess of \$250,000; and

1 WHEREAS, The General Manager of the San Francisco Public Utilities Commission
2 estimates that the emergency work to replace the main sewer on California Street from Cherry
3 Street to Arguello Boulevard will cost approximately \$449,273; now therefore be it

4 RESOLVED, That the General Manager of the San Francisco Public Utilities
5 Commission is authorized to award an emergency contract under San Francisco
6 Administrative Code Section 6.60, and proceed with all work necessary to replace the main
7 sewer on California Street from Cherry Street to Arguello Boulevard, with a total contract
8 amount not to exceed ~~\$449,273~~ \$389,883; and, be it

9 FURTHER RESOLVED, That the Controller has certified that funds are available for
10 this emergency contract; and be it

11 FURTHER RESOLVED, That any action to date by the San Francisco Public Utilities
12 Commission to secure such emergency contract and resolve the emergency condition is
13 hereby ratified.
