WHEREAS, DPH was awarded a grant from the WHO in the amount of \$14,500 for a project entitled MSM Target Setting Guide; for the period of December 15, 2009 through December 31, 2009; and,

WHEREAS, The purpose of this grant is to develop a technical guide for HIV care and prevention programs targeted at men who have sex with men (MSM) and transgendered individuals; and,

WHEREAS, The grant does not require an ASO amendment and reimburses DPH for two existing positions: one Senior Physician Specialist (Job Class #2232) at 0.80 FTE, and one Health Program Coordinator III (Job Class #2593) at 0.90 FTE, for the period of December 15, 2009 through December 31, 2009; and,

Whereas, DPH is seeking retroactive approval because DPH did not receive the award letter from WHO until December 18, although the effective date was December 15, 2009; and,

WHEREAS, The grant budget includes a provision for indirect costs in the amount of \$2,565; now, therefore, be it

RESOLVED, That DPH is hereby authorized to retroactively accept and expend a grant in the amount of \$14,500 from the WHO; and, be it
