Resolution authorizing the Director of Public Works to execute an amendment to the design agreement for the Laguna Honda Hospital Replacement Program increasing the contract amount from \$45,129,101 to \$50,799,281.

WHEREAS, The Director of Public Works had entered into an agreement dated November 30, 2000 with Anshen+Allen/Stantec, A Joint Venture for the design of the Laguna Honda Hospital Replacement Program in an amount of not to exceed \$2,400,352; and,

WHEREAS, Section 9.118(b) of the Charter requires that all agreements in excess of ten million dollars or amendments to said agreements in excess of \$500,000, or the term of any agreement extending beyond ten years, be approved by the Board of Supervisors; and,

WHEREAS, Resolutions 994-01, 579-03, 561-04, 667-05, 57-07 and 358-08, the Board of Supervisors had authorized the Director to enter into amendments to the agreement which when amended would not exceed \$45,129,101; and,

WHEREAS, the Director intends to increase the scope of services under said agreement to extend construction administration services, augment architectural staff, and provide redesign services and to increase the contract amount under said agreement to \$50,799,281; and

WHEREAS, the term of the agreement will exceed the ten year limit; and,

WHEREAS, the Director intends to increase the term beyond the ten year limit from November 30, 2010 to December 31, 2012; now, therefore, be it

RESOLVED, That the Board of Supervisors does hereby authorize the Director of Public Works to enter into the amendment to the November 30, 2000 agreement with
