Resolution approving Amendment No. 1, retroactive to April 14, 2011, to Domestic Terminal Food and Beverage Lease No. 03-0192 with J. Avery Enterprises, dba Klein's Deli, and the City and County of San Francisco, acting by and through its Airport Commission.

RESOLUTION NO.

WHEREAS, The Airport intends to close Boarding Area B in or around May 2011 for an unknown period; and

WHEREAS, The Airport will close Boarding Area E for approximately one year for major renovations; and

WHEREAS, J. Avery Enterprises operates Klein's Deli in Boarding Areas B and E ("Original Premises"); and

WHEREAS, The closures of Boarding Areas B and E also requires the closure of the Original Premises; and

WHEREAS, The Airport Commission approved the terms for Amendment No. 1 to the Lease by Resolution No. 11-0084, which includes a change in the Premises, suspension and reinstatement of the Minimum Annual Guarantee and Tenant Infrastructure Fee, an extension of the Lease Term, and a reimbursement to the Tenant for unamortized cost of improvements for the Original Premises; now, therefore, be it

RESOLVED, That the Board of Supervisors hereby approves Amendment No. 1, retroactive to April 14, 2011, to Lease No. 03-0192 with J. Avery Enterprises, as follows:

1. The Boarding Area E Renovation Period commences on April 14, 2011 and ends when the Airport Director, in his sole and absolute discretion, determines that the renovations are complete.

 Expansion in Boarding Area E location from 642 square feet to 1,323 square feet;

 Relocation of 518 square feet in Boarding Area B to 998 square feet in Boarding Area F.

- 3. Replacement of the existing ten (10) year term with a new ten (10) year term, which commences on the earlier of (i) the date both the Boarding Area E and Boarding Area F locations are both open to the public, or (ii) airline tenants occupy the majority of gates in Boarding Area E.
- 4. A reimbursement of unamortized construction costs calculated at \$136,576 for Boarding Area B, and \$157,427 for Boarding Area E.
- 5. Minimum Annual Guarantee ("MAG")
 - Termination of the MAG associated with Boarding Area B;
 - Suspension of the MAG associated with Boarding Area E and its reinstatement upon the first day that airline tenants reoccupy the majority of gates at Boarding Area E.
 - Commencement of the MAG for Boarding Area F on the earlier of (i) the date the space opens for business, or (ii) one hundred and twenty (120) days after construction commences.
- 6. Tenant Infrastructure Fee
 - Termination of the Tenant Infrastructure Fee associated with Boarding Area B.
 - Suspension of the Tenant Infrastructure Fee during the Renovation Period and its reinstatement upon the first day that airline tenants reoccupy the majority of gates at Boarding Area E.

FURTHER RESOLVED, That the Airport Director shall take all steps necessary to implement such Amendment No. 1 to the Lease, including execution of the appropriate documents.
