WHEREAS, In 1983, the Airport and Compania Mexicana de Aviacion S.A. de C.V., doing business as Mexicana Airlines, a Mexico corporation ("Mexicana"), entered into a longterm Airline-Airport Lease and Use Agreement No. L83-0045 and other permits (the "Lease") enabling Mexicana to operate at the San Francisco International Airport; and

WHEREAS, Mexicana delivered to the Airport a performance bond (the "Bond") issued by Travelers, in the amount of \$452,804 as a security deposit under the Lease; and

WHEREAS, On or about August 3, 2010, Mexicana ceased operating at the Airport, defaulted on the Lease, and petitioned for voluntary bankruptcy in Mexico and in the United States; and

WHEREAS, The City made a demand on the Travelers surety bond for the full penal sum of the bond (\$452.804) and Travelers denied that claim; and.

WHEREAS, The Airport and Travelers negotiated a settlement requiring Travelers to pay the Airport \$250,000 in exchange for Travelers' right to file an indemnity claim in the Mexicana bankruptcy; now, therefore, be it;
