[Contract Amendment - CCT Technologies, Inc., dba ComputerLand of Silicon Valley - \$43,850,000]

Resolution authorizing the Office of Contract Administration to enter into the Fifth Amendment between the City and CCT Technologies, Inc., dba ComputerLand of Silicon Valley (part of the Technology Store procurement vehicle), in which the amendment shall increase the contract limit from \$34,950,000 to \$43,850,000 for the term ending December 31, 2013.

WHEREAS, The Office of Contract Administration, by competitive bidding, developed the Technology Store procurement method for the purchase of products and services related to Information Technology; and

WHEREAS, CCT Technologies, Inc., dba ComputerLand of Silicon Valley is one of the three products vendors who are part of the Technology Store; and

WHEREAS, The original contract with CCT Technologies, Inc., dba ComputerLand of Silicon Valley dated January 1, 2009 has a term of three years through December 31, 2011 with options to extend the term through December 31, 2013, and has an original contract limit of \$24,000,000; and

WHEREAS, The Board of Supervisors approved the original contract on December 9, 2008 by Resolution #508-08; and

WHEREAS, The Director of the Office of Contract Administration and the Purchaser approved the First Amendment to the contract on December 14, 2011 to exercise the first of two options to extend the contract by one year through December 31, 2012, and to update standard contractual clauses; and

WHEREAS, The Director of the Office of Contract Administration and the Purchaser approved the Second Amendment to the contract on June 28, 2012 to

increase the contract limit from \$24,000,000 to \$24,490,000; and

WHEREAS, The Board of Supervisors approved the Third Amendment to the contract on September 25, 2012 by Resolution #354-12 to increase the contract limit from \$24,490,000 to \$34,460,000 to exercise the second of the two options to extend the contract by one year through December 31, 2013, and update standard clauses; and

WHEREAS, The Director of the Office of Contract Administration and the Purchaser approved the Fourth Amendment to the contract on July 02, 2013 to increase the contract limit from \$34,460,000 to \$34,950,000; and

WHEREAS, The Office of Contract Administration estimates that the money projected to be spent with CCT Technologies, Inc., dba ComputerLand of Silicon Valley could reach the contract's limit in the reasonably near future; and

WHEREAS, Charter section 9.118(b) "Contract and Lease Limitations," requires the Board of Supervisors to approve any contract estimated to exceed \$10 million in expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be it

RESOLVED, That the Board of Supervisors authorizes the Director of the Office of Contract Administration and the Purchaser to enter into the Fifth Amendment to the contract with CCT Technologies, Inc., dba ComputerLand of Silicon Valley to increase the contract limit from \$34,950,000 to \$43,850,000 in substantially the form on file with the Clerk of the Board in such final form as approved by the Purchaser and Director of the Office of Contract Administration and the City Attorney; and, be it

FURTHER RESOLVED, That within thirty (30) days of the contract being fully executed by all parties, the Purchaser and Director of the Office of Contract
