3 **Resolution retroactively authorizing the Office of the District Attorney to accept an**
4 **in-kind gift of Prosecution and Racial Justice Program technical assistance valued**
5 **at \$408,654 from the Vera Institute of Justice for the grant period of January 1,**
6 **2014, through June 30, 2015.**

8 WHEREAS, The City and County of San Francisco Office of the District Attorney is
9 designated as chair for the San Francisco Sentencing Commission; and

11 WHEREAS, The Vera Institute of Justice (Vera), an independent, nonpartisan,
12 nonprofit center for justice policy and practice that combines expertise in research,
13 demonstration projects, and technical assistance to help leaders in government and civil
14 society improve the systems people rely on for justice and safety, in partnership with the
15 San Francisco District Attorney's Office (SFDA), will provide research and program
16 planning services under the Prosecution and Racial Justice Program; and

18 WHEREAS, Vera has proposed to provide the City with an in-kind gift of technical
19 assistance valued at \$408,654 for the San Francisco District Attorney's Office and any
20 indirect costs are born by the provider and no actual or indirect costs will be incurred by
21 the District Attorney's Office; and

23 WHEREAS, The District Attorney proposes to maximize use of available grant
24 funds on program expenditures by not including indirect costs in the grant budget; and

26 WHEREAS, The gift does not require an ASO Amendment; now, therefore, be it





3 from Vera for research and program planning services; and be it


4 FURTHER RESOLVED, That the Board of Supervisors hereby waives inclusion of
