## Joining the Sunshine Meeting Via Internet

1. Navigate to Zoom in your web browser by typing **zoom.us** into the search bar.
2. Click **Join a Meeting** located at the upper right-hand corner of your screen.
3. Enter the Meeting ID into the **Meeting ID field: 915 6885 2708**.
4. When prompted, enter the **Password: 237902**.
5. If prompted, please enter your email address and your name in the fields provided. Please note that when submitting a public comment, you will be identified by your Zoom name. In order to ensure that we give everyone an equal opportunity to speak, we have disabled the option to remain anonymous for this call.
6. **Click Join.**

## To participate in the Sunshine Meeting via internet, please engage using the following steps:

1. To indicate that you have a question/comment and would like to be unmuted, please write your name in the **chat**.

### Chat

- a. Click **Chat** to open the in-meeting chat.

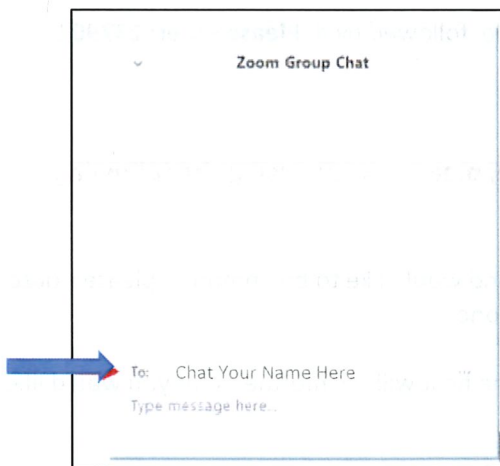


- b. The chat will appear on the right side of your Zoom window (if you are not in full screen). If you are in full screen, it will appear in a window that you can move around your screen as needed.



c. To submit a request for public comment (and request to be unmuted), please click on the option that says **“To:”** A drop down menu will appear, please select the name titled **“Chat Your Name Here.”** Please type your name in the chat, press enter, and we will call you in the order that your name appears.

Please note that when submitting a public comment, you will be identified by your Zoom name.



d. When it is your turn to speak, the hosts will identify you by your name as it appears on Zoom followed by **“your line has been unmuted.”** This is your opportunity to provide your public comment for up to two minutes.



### **Best Practices when Providing Public Comment**

- Call from a quiet location
- Speak slowly and clearly
- Turn down any televisions or radios around you

e. Each speaker will be given two minutes to provide their public comment.

f. Once your two minutes have ended, you will be muted, and you will return to listening mode (unless you disconnect).

### **Joining a Sunshine Meeting by Telephone Only**

1. Dial in the following telephone number: **1 669 900 6833**.
2. You will be prompted to enter the Meeting ID: **915 6885 2708, followed by #**.
3. If the meeting has not already started by the host, press # to wait for the host to begin the meeting.
4. You may be prompted to enter your *unique* participant ID. **This does not apply to you as a participant**. Press # to skip.
5. You may be prompted to enter the meeting passcode, followed by #. **Please enter: 237902, followed by #**.

### **To participate in the Sunshine Meeting via telephone, please engage using the following steps:**

a. To indicate that you have a question/comment and would like to be unmuted, please utilize the **Raise Hand** feature by dialing **\*9** in your telephone.

c. You will receive a verbal notification that says “the host will be informed that you would like to speak.” Your digital hand is now raised.

d. When it is your turn to speak, one of two options will happen:

- The hosts will identify you by your name as it appears on Zoom or by your area code and the last 3 digits of your phone number, followed by “you have been unmuted.” This is your opportunity to provide your public comment.



- You will receive one verbal notification saying “Host would like you to unmute.” If you receive this notification, it is your turn to speak. Please press **\*6 to unmute yourself**.
