NOTICE IS HEREBY GIVEN THAT the Board of Supervisors of the City and County of San Francisco's Budget and Finance Committee will hold a public hearing to consider the following proposal and said public hearing will be held as follows:

1. Which time all interested parties may attend and be heard: File No. 230980. Ordinance amending the Administrative Code to increase the fees imposed by the Department of Administrative Services for reproduction and notary services provided to the public, and authorizing the Controller to make future adjustments to ensure that costs of providing the services are recovered without producing revenue which is significantly more than such costs. If this legislation passes, amendments to Administrative Code, Section 8.44, will increase fees that the Department of Administrative Services charges for document reproduction and notary services available to the public at the City's Permit Center. Temporary parking restriction ("no parking") signs required under the Transportation Code increases from \$5.00 to \$7.00 per sign; black and white printing of standard sized documents (8.5x11, 8.5x14, 11x17) increases from \$0.77 to \$0.81 per sq. ft. and large format (greater than 11x7) documents increases from \$2 to \$2.11 per sq. ft. In accordance with Administrative Code, Section 67.7-1, persons who are unable to attend the hearing on this matter may submit written comments prior to the time the hearing begins. These comments will be made as part of the official public record in this matter and shall be brought to the attention of the Board of Supervisors.
