Central Park provides open space and recreational and cultural resources for the downtown, as well as the entire San Mateo community. New features to be added include a new community plaza along 5th Avenue, fallen hero memorial, a new community event building, new tennis courts with lighting, new Rotary Picnic Pavilion, and a storage building.

Features to be expanded and improved include the existing playground, picnic areas, the Laurel Avenue entryway, Fitzgerald ballfield, the parking garage on 5th Avenue, and the pedestrian path system.

Key features to be preserved include the Japanese Tea Garden, Kohl Pumphouse Kohl Fence Rose Garden Main Event Lawn Maintenance Yard Children's Mini Train, Gazebo, and all of the existing art pieces on site would be preserved including the bronze dog (near 9th Avenue entry), bronze bears (near 9th Avenue entry) and Leon, the Giraffe (near 5th Avenue).
