This fee shall be paid to Public Works in accordance with Public Works Code, Section 793.2(b). A City Agency or Department may also charge additional fees for permits required, or services performed, to implement the People Place Proposal submitted by a Steward, but shall be one-half the fee that the Agency or Department is authorized to charge.

In accordance with Administrative Code, Section 67.7-1, persons who are unable to attend the hearing on this matter may submit written comments to the City prior to the time the hearing begins.
