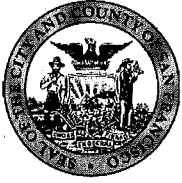

10 WHEREAS, On September 22, 2017, the Board of Supervisors adopted Ordinance No.
11 190-17, imposing an interim zoning moratorium on the approval of medical cannabis
12 dispensaries for 45 days, in accordance with California Government Code, Section 65858;
13 affirming the Planning Department’s determination under the California Environmental Quality
14 Act; and making findings of consistency with the General Plan, and the eight priority policies
15 of Planning Code, Section 101.1; a copy of this ordinance is on file with the Clerk of the Board
16 in File No. 170865 and is available on the Board’s website; and

17 WHEREAS, This ordinance and the State law on the adoption of interim moratoria,
18 California Government Code, Sections 65858 et seq., require the Board of Supervisors to
19 adopt a written report describing the measures taken to alleviate the conditions that led to the
20 adoption of the ordinance; and,

21 WHEREAS, The Planning Department prepared such a report and submitted it to the
22 Clerk of the Board of Supervisors on October 6, 2017, for the Board’s consideration; a copy of
23 said report is on file with the Clerk of the Board of Supervisors in File No. 170865; now,
