13 between the ages of 18 and 60, authorized to represent organizations that advocate for  
14 younger people with disabilities, for the unexpired portion of a three-year term ending March  
15 1, 2022;

16 Rita Semel, seat 6, succeeding herself, term expired, must be a member of the  
17 Human Services Commission, recommended to the Board by the Commission, for the  
18 unexpired portion of a three-year term ending March 1, 2022;

19 Jim Blacksten, seat 9, succeeding Tatiana Kostanian, term expired, must be a member  
20 of the Mayor's Disability Council, recommended to the Board by the Council, for the unexpired  
21 portion of a three-year term ending March 1, 2022;

22 Melvin Beetle, seat 10, succeeding himself, term expired, must be a consumer over  
23 the age of 55, authorized to represent organizations that advocate for aging people with  
24 disabilities, for the unexpired portion of a three-year term ending March 1, 2022.
