WHEREAS, The Board of Supervisors wishes to authorize the listed Board Members or sponsor, supporting the following ballot measures, to prepare and submit a written proponent ballot arguments and proponent rebuttal arguments for submittal to the Director of Elections:

- San Francisco to change the name of the Aging and Adult Services Commission to the Disability and Aging Services Commission, and establish qualifications for three of the Commission seats; change the name of the Department of Aging and Adult Services to the Department of Disability and Aging Services; and to change the name of the Aging and Adult Services Community Living Fund to the Disability and Aging Services Community Living Fund to the Disability and Aging Services Community Living Fund; at an election to be held on November 5, 2019. (Board File No. 190570) (President Yee)
- Ordinance calling and providing for a special election, for the purpose of submitting to San Francisco voters a proposition to incur bonded indebtedness of not-to-exceed \$600,000,000 to finance the construction, development, acquisition, improvement, rehabilitation, preservation, and repair of affordable housing improvements, and related costs necessary or convenient for the foregoing purposes; authorizing landlords to pass-through 50% of the resulting property tax increase to residential tenants under Administrative Code Chapter 37; providing for the levy and collection of taxes to pay both principal and interest on such Bonds:

incorporating the provisions of the Administrative Code relating to the Citizens' General Obligation Bond Oversight Committee's review of Affordable Housing Bond expenditures; setting certain procedures and requirements for the election; adopting findings under the California Environmental Quality Act; and finding that the proposed Bonds are in conformity with the General Plan, and with the eight priority policies of Planning Code, Section 101.1(b). (Board File Nos. 190495 & 190501)

- Initiative Ordinance amending the Business and Tax Regulations Code and Administrative Code to impose an excise tax on the net rider fares for rides facilitated by commercial ride-share companies and rides provided by autonomous vehicles and private transit services vehicles, to fund transportation operations and infrastructure for traffic congestion mitigation in the City; and to increase the City's appropriations limit by the amount collected under the tax for four years from November 5, 2019. (Board File No. 190584) (Mayor Breed)
- Initiative Ordinance submitted by four or more Supervisors to the voters, entitled "Ordinance amending the Planning Code to create the 100 Percent Affordable Housing and Educator Housing Streamlining Program; to allow affordable housing and affordable teacher housing in Public zoning districts; and to provide timelines for the review and approval of affordable housing and affordable teacher housing." (Board File No. 190720) (Supervisor Fewer)
- Initiative Ordinance submitted by four or more Supervisors to the voters, entitled "Ordinance amending the Campaign and Governmental Conduct Code to prohibit campaign contributions from limited liability companies and limited liability partnerships; prohibit campaign contributions to members of and candidates for the Board of Supervisors, the Mayor and candidates for Mayor, the City Attorney and

candidates for City Attorney, and the controlled committees of those officials and candidates, from any person with pending or recently resolved land use matters before the City; and expand disclaimer requirements for independent expenditure committee advertisements." (Board File No. 190723) (Supervisor Mar)

WHEREAS, The Board of Supervisors wishes to authorize the listed Board Member opposed to the following ballot measure to prepare and submit a written opponent ballot argument and opponent rebuttal ballot argument for submittal to the Director of Elections:

Initiative Ordinance submitted by petition to the voters, amending the Health Code,
entitled "An Act to Prevent Youth Use of Vapor Products." (Supervisor Walton)

WHEREAS, The Board Members or sponsor authorized by this Motion to submit the ballot arguments will submit the proponent/opponent arguments to the Director of Elections no later than the deadline of noon, August 15, 2019, and the respective rebuttal proponent/opponent ballot arguments no later than noon, August 19, 2019; now, therefore, be it

MOVED, That the Board of Supervisors hereby authorizes the Board Members or sponsor listed above, under Municipal Elections Code, Sections 530 and 550, to prepare and submit written proponent/opponent ballot arguments and respective rebuttal proponent/opponent ballot arguments on the listed measures as referenced; and, be it

FURTHER MOVED, That the Board Members or sponsor who are authorized by this Motion to prepare and submit proponent/opponent ballot arguments, may authorize or assign to any other person(s) under Municipal Elections Code, Section 550(c) and (d), to prepare and submit the proponent/opponent's ballot arguments and/or respective rebuttal arguments.
