

1 [Appointments, Office of Early Care and Education Citizens' Advisory Committee - Monica
2 Walters, Sara Hicks-Kilday, Patricia Sullivan, and June Lin-Arlow]

3 **Motion appointing Monica Walters (residency requirement waived) and Sara Hicks-**
4 **Kilday (residency requirement waived), terms ending May 1, 2022, and Patricia Sullivan**
5 **and June Lin-Arlow, terms ending May 1, 2023, to the Office of Early Care and**
6 **Education Citizens' Advisory Committee.**

8 MOVED, That the Board of Supervisors of the City and County of San Francisco does
9 hereby appoint the hereinafter designated persons to serve as members of the Office of Early
10 Care and Education Citizens' Advisory Committee, pursuant to the provisions of
11 Administrative Code, Section 5.120, et seq., for the terms specified:

12 Monica Walters (residency requirement waived), Seat 7, succeeding Yohana Quiroz,
13 term expired, must be a provider of early care and education at a community-based childcare
14 center in San Francisco, but this member cannot be a San Francisco Unified School District
15 provider, for the unexpired portion of a two-year term ending May 1, 2022;

16 Sara Hicks-Kilday (residency requirement waived), Seat 9, Sandee Blechman,
17 resigned, must be a representative of the Childcare Planning and Advisory Council and
18 nominated to the Board of Supervisors, for the unexpired portion of a two-year term ending
19 May 1, 2022;

20 Patricia Sullivan, Seat 6, succeeding herself, term expired, must be a family child
21 care provider, for a two-year term ending May 1, 2023;

22 June Lin-Arlow, Seat 8, succeeding Candace Wong, resigned, must be a family
23 support provider, a provider or educator who works with children with special needs, a
24 community member with expertise in early education, a member of the mental health

1 community specializing in early care, a member of philanthropic organization, or a member of
2 the business community with an interest in early care and education issues, for a two-year
3 term ending May 1, 2023; and, be it

4 FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 5 1. The membership of the Office of Early Care and Education Citizens' Advisory
6 Committee has a goal to be representative of the diversity of the City and County of
7 San Francisco.
- 8 2. Applicants Monica Walters and Sara Hicks-Kilday, who are not residents of San
9 Francisco, are persons with experience that uniquely qualifies them to serve on the
10 Office of Early Care and Education Citizens' Advisory Committee.
- 11 3. The Office of Early Care and Education Citizens' Advisory Committee has attempted to
12 fill the positions, for which Monica Walters and Sara Hicks-Kilday were nominated, with
13 individuals who are City residents and who have the specific experience, skills, and
14 qualifications, but has been unable to do so at this time. The Rules Committee has
15 certified that Monica Walters and Sara Hicks-Kilday, are qualified to serve on the Office
16 of Early Care and Education Citizens' Advisory Committee.
- 17 4. After exercising due diligence, the Board of Supervisors concludes that there are no
18 other possible representatives who are residents of San Francisco, who have the
19 specific experience, skills, or qualifications possessed by these applicants, and who
20 are willing to serve on the Office of Early Care and Education Citizens' Advisory
21 Committee at this time; and, be it

22 FURTHER MOVED, That the Board of Supervisors waives the residency requirement for
23 Monica Walters and Sara Hicks-Kilday, as is allowed in cases where no qualified City
24 residents who are willing to serve can be found, pursuant to Charter, Section 4.101(a)(2), that
25 otherwise requires person(s) appointed to boards, commissions, and advisory bodies

1 established by legislative act of the Board of Supervisors to be resident(s) of the City and
2 County of San Francisco.

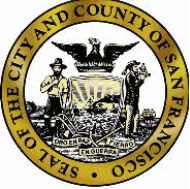
