9 WHEREAS, The African American Reparations Advisory Committee was established
10 through Ordinance No. 259-20 in 2020 to develop, adopt, and implement a San Francisco
11 Reparations Plan; and

12 WHEREAS, In December 2022, the African American reparations Advisory Committee
13 submitted a Draft San Francisco Reparations Plan to incorporate feedback from the Board of
14 Supervisors, the Mayor, the Human Rights Commission, and the public; and

15 WHEREAS, The Dream Keeper Initiative was established in 2021 as a citywide effort
16 to reinvest \$60 million annually into San Francisco's diverse Black communities for reforming
17 public safety and addressing structural inequities in San Francisco; and

18 WHEREAS, Since its inception, the Dream Keeper Initiative has awarded 141 Black-
19 led and Black-serving organizations to implement services that advance the Dream Keeper
20 Initiative goal; now, therefore, be it

21 **MOVED, That the Board of Supervisors of the City and County of San Francisco**
22 **convene as a Committee of the Whole on Tuesday, February 7, 2023, at 3:00 p.m., to hold a**
23 **public hearing on the Draft San Francisco Reparations Plan and Dream Keeper Initiative**

25 **Advisory Committee, and the Dream Keeper Initiative to present.**
