(1) Under Charter Section 4.105 and Planning Code Section 340, any amendments to the General Plan shall first be considered by the Planning Commission and

(a) California Environmental Quality Act Findings. The Planning Department has

thereafter recommended for approval or rejection by the Board of Supervisors. On October 25, 2018, by Resolution No. 20326, the Commission conducted a duly noticed public hearing on the General Plan Amendment pursuant to Planning Code Section 340, and found that the public necessity, convenience, and general welfare required the proposed General Plan Amendment, and recommended it for approval to the Board of Supervisors. The Board adopts these findings as its own. A copy of said resolution is on file with the Clerk of the Board of Supervisors in File No. 181112, and is incorporated herein by reference.

(2) On October 25, 2018, the Planning Commission, in Resolution No. 20326, adopted findings that the actions contemplated in this ordinance are consistent, on balance, with the City's General Plan and eight priority policies of Planning Code Section 101.1. The Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the Board of Supervisors in File No. 181112, and is incorporated herein by reference.

Section 2. The San Francisco General Plan is hereby amended by revising Map 1 of the Market and Octavia Area Plan to change the designation of 1650, 1660, 1670 and 1680 Mission Street, Assessor's Parcel Number No. 3512, Lot Nos. 005, 006, 008, 009, and 010, as recommended to the Board of Supervisors by the Planning Commission in Resolution No. 20326, as follows:
