2 Department of Cannabis Control - Local Jurisdiction Assistance Grant Program - \$3,075,769]

3 Ordinance retroactively authorizing the Office of Cannabis to accept and expend a
4 grant award in the amount of \$3,075,769 from the Department of Cannabis Control for
5 the Local Jurisdiction Assistance Grant Program for a term of ~~on-or-around February~~
6 ~~14~~January 1, 2022, through ~~March 31~~June 30, 2025; and amending Ordinance
7 No. 109-21 (Annual Salary Ordinance File No. 210644 for Fiscal Years 2021-2022 and
8 2022-2023) to provide for the addition of one grant funded Class 1824 Principal
9 Administrative Analyst position (FTE 0.20), one grant funded Class 1823 Senior
10 Administrative Analyst position (FTE 1.0), and three grant funded class 1822
11 Administrative Analyst positions (FTE 3.0) at the Office of Cannabis for the period of
12 ~~on-or-around February 14~~January 1, 2022, through ~~March 31~~June 30, 2025.

20 Be it ordained by the People of the City and County of San Francisco:

21 **Section 1. Findings.**

22 (a) In November 2016, California voters approved Proposition 64, the Control,
23 Regulate and Tax Adult Use of Marijuana Act ("Proposition 64"), which legalized adult use
24 cannabis in California for individuals 21 years of age and older. SB 129 (Stats. 2021, Ch. 69)
25 created the Local Jurisdiction Assistance Grant Program, administered by the Department of
Cannabis Control ("Department"), to dedicate funding to local jurisdictions with the greatest

1 needs to transition provisional commercial cannabis licenses to annual commercial cannabis
2 licenses.

3 (b) The San Francisco Office of Cannabis (“Office of Cannabis”) operates a local
4 social equity program for commercial cannabis activity, created by Ordinance No. 230-17,
5 approved December 6, 2017, effective January 5, 2018.

6 (c) In May 2021, the Department notified the Office of Cannabis of its intent to
7 award a grant of \$3,075,769 to support the processing of commercial cannabis applications
8 by the Office of Cannabis for a term of on or around February 11, 2022 through March 31,
9 2025.

10 (d) In November 2021, the Office of Cannabis submitted an application to the
11 Department for a grant from the Local Jurisdiction Assistance Grant Program to support the
12 Office of Cannabis’ efforts to transition temporary local permits and provisional state licenses
13 to permanent local permits and state licenses by funding additional staff and capacity in the
14 Office of Cannabis for the referral and review of commercial cannabis applications. Staff
15 duties may include researching, analyzing and making policy recommendations; directing
16 complex financial and operational activities; responding to informational requests, and
17 representing the office to the Mayor’s office, Board of Supervisors, Controller’s Office, other
18 city officials, and outside agencies and the public, as well as providing administrative analysis
19 to high-level city officials regarding the commercial cannabis application process.

20 ~~(d) — In May 2021, Department notified the Office of Cannabis of its intent to award a~~
21 ~~grant of \$3,075,769 to the Office of Cannabis to support the processing of commercial~~
22 ~~cannabis applications on or around February 11, 2022 through March 31, 2025.~~

23 **Section 2. Authorization to accept and expend grant funds.**

24 (a) The Board of Supervisors hereby retroactively authorizes the City Administrator
25 and/or the Office of Cannabis to accept and expend, on behalf of the City and County of San

1 Francisco, a Local Jurisdiction Assistance grant from the Department, and for retroactively
2 authorizes the Deputy City Administrator to sign the Department grant agreement included in
3 BOS File No. 220001 (the "Grant Agreement"), including any amendments thereto.

4 (b) The Board of Supervisors agrees that the funds received under the Grant
5 Program shall not be used to supplant expenditures controlled by this body.

6 (c) The Board of Supervisors, on behalf of the City and County of San Francisco,
7 agrees to abide by the terms and conditions of the Grant Agreement.

8 (d) The Grant Agreement includes a provision for indirect costs of \$25,000 and the
9 Board of Supervisors approves inclusion of indirect costs in the Office of Cannabis budget for
10 expending the Grant Program.

11
12 **Section 3. Grant funded positions; Amendment to Fiscal Year 2021-2022 and**
13 **Fiscal Year 2022-2023-Annual Salary Ordinance.**

14 The hereinafter designated sections and items of Ordinance No.- 109-21 (Annual
15 Salary Ordinance File No. 210644 for FY 2021-2022 and FY 2022-2023) are hereby amended
16 so that the same shall read as follows:


