22 settlement, and the City's obligation to convey the easement, are contingent on the
23 occurrence of a number of events, including court approval of a class action
24 settlement; adopting environmental findings.

1 Be it ordained by the People of the City and County of San Francisco:

2 Section 1. General Findings and Environmental Findings.

3 (a) This ordinance is companion legislation to related Board of Supervisors actions
4 including Resolution No. 069-20 regarding a Public Trust Exchange for portions of public right-
5 of-way affected by the Millennium Tower structural upgrade, an ordinance vacating portions of
6 the public right-of-way for the structural upgrade, and legislation for an easement to the
7 vacated public right-of-way for construction, installation, and monitoring of the structural
8 upgrade. The companion legislation is in Clerk of the Board of Supervisors File Nos. 191286,
9 and 191253, respectively and is incorporated herein by reference.

10 (b) The street vacation ordinance and easement legislation are conditioned upon
11 approval of this settlement ordinance.

12 (c) The street vacation ordinance adopted general findings about the public purposes
13 supporting the Millennium Tower structural upgrade and adopted environmental findings
14 under the California Environmental Quality Act (CA Public Resources Code Sections 21000 et
15 seq. ("CEQA")). This settlement ordinance is within the scope of the City's CEQA review.
16 The Board of Supervisors adopts the general findings and environmental findings associated
17 with the street vacation ordinance for purposes of this settlement ordinance.

18 Section 2. The Millennium Tower Litigation.

24 to enter into any amendments or modifications to the settlement documents that the City
25 Administrator determines in consultation with the City Attorney are in the best interest of the


1 City; do not materially increase the obligations or liabilities of the City; are necessary or
2 advisable to effectuate the purposes and intent of the settlement documents or this
3 Ordinance; and are in compliance with all applicable laws.



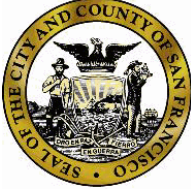
