4 **Transient Use under the Hotel Conversion Ordinance, to change the term of tenancy**  
5 **from less than 32 days to less than 30 days, revising the provision in the**  
6 **Administrative Code providing that the term of tenancy is less than 32 days and**  
7 **superseding the City's temporary stipulated agreement that the term of tenancy is less**  
8 **than seven days; and affirming the Planning Department's determination under the**  
9 **California Environmental Quality Act; ~~and making findings of consistency with the~~**  
10 **~~General Plan and the eight priority policies of Planning Code, Section 101.1, and~~**  
11 **~~findings of public necessity, convenience, and welfare, under Planning Code, Section~~**  
12 **302.**

20 Be it ordained by the People of the City and County of San Francisco:

21 Section 1. Findings.

22 (a) The Planning Department has determined that the actions contemplated in this  
23 ordinance comply with the California Environmental Quality Act (California Public Resources  
24 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of  
25 Supervisors in File No. 190049 and is incorporated herein by reference. The Board affirms  
this determination.

1           (b) On \_\_\_\_\_, the Planning Commission, in Resolution No. \_\_\_\_\_,  
2 adopted findings that the actions contemplated in this ordinance are consistent, on balance,  
3 with the City's General Plan and eight priority policies of Planning Code Section 101.1. The  
4 Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk of  
5 the Board of Supervisors in File No. \_\_\_\_\_, and is incorporated herein by reference.

6           (c) Pursuant to Planning Code Section 302, this Board finds that this Planning Code  
7 amendment will serve the public necessity, convenience, and welfare for the reasons set forth  
8 in Planning Commission Resolution No. \_\_\_\_\_ and adopted on \_\_\_\_\_, and the Board  
9 incorporates such reasons herein by reference. A copy of said resolution is on file with the  
10 Clerk of the Board of Supervisors in File No. \_\_\_\_\_ and is incorporated herein by  
11 reference.

13           Section 2. Chapter 41 of the Administrative Code is hereby amended by revising  
14 Section 41.4, to read as follows:

15           **SEC. 41.4. DEFINITIONS.**

16           \* \* \* \*

17           **Tourist or Transient Use.** Any use of a guest room for less than a ~~30~~32-day term of  
18 tenancy by a party other than a Permanent Resident.

19           \* \* \* \*

21           Section 3. Effective Date. This ordinance shall become effective 30 days after  
22 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
23 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
24 of Supervisors overrides the Mayor's veto of the ordinance.

1 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
2 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
3 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
4 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
5 additions, and Board amendment deletions in accordance with the "Note" that appears under  
6 the official title of the ordinance.


