17 County of San Francisco and the San Francisco Police Officers Association, to restore  
18 effective June 30, 2022, a deferred one percent (1%) base wage increase originally due on  
19 July 1, 2020.

21 Supervisors in Board File No. 220594.

22 Section 2. The Board of Supervisors hereby authorizes the Department of Human  
23 Resources to make non-substantive ministerial or administrative corrections to the MOU.


