14	the percentage ceiling that a taxpayer may designate for deposit in the Neighborhood		
15	Beautification and Graffiti Clean-up Fund. Said determination is on file with the Clerk of the		
16	Board of Supervisors in File No. 200831, and is incorporated herein by reference. For the		
17	2020 tax year, the designation ceiling shall be 3.8% of a taxpayer's payroll expense tax and		
18	gross receipts tax liability for the year.		
19	The Treasurer and Tax Collector shall post the designation ceiling to the website of the		
20	Treasurer and Tax Collector.		
21	Section 2. Effective Date. This ordinance shall become effective 30 days after
