The Mayor's Office of Housing and Community Development shall provide a report to the Board of Supervisors regarding the final implementation rules for the distribution of the direct allocation of federal rent relief funding. The uses of funding for \$146,800,000 are herein placed on Controller's Reserve pending sale of Certificates of Participation, sale of commercial paper as interim financing, or the confirmation of sufficient commercial paper program capacity to certify available funds.

Section 4. The Controller is authorized to record transfers between funds and adjust the accounting treatment of sources and uses appropriated in this ordinance as necessary to conform with Generally Accepted Accounting Principles and other laws, and adjust sources and uses amounts to reflect local baseline funding mandates.
