

[Police Code - Fixed Place Outdoor Amplified Sound Permit and License Fees]

**Ordinance amending the Police Code to update the Fixed Place Outdoor Amplified Sound permit filing fee, permit amendment filing fee, and license fee to current amounts.**

Be it ordained by the People of the City and County of San Francisco:

Section 1. The Police Code is hereby amended by revising Sections 2.26 and 2.27 of Article 1, to read as follows:

**SEC. 2.26. SCHEDULE OF PERMITS AND SERVICES; FILING AND SERVICE FEES.**

The following filing and service fees, payable in advance to the City and County of San Francisco, are required when submitting applications for the specified permits to the Police Department or Entertainment Commission or when paying for the specified services:

1           **SEC. 2.27. SCHEDULE OF LICENSE FEES FOR PERMITS ISSUED BY THE**  
 2 **POLICE DEPARTMENT OR ENTERTAINMENT COMMISSION.**

3           The following license fees are payable to the Tax Collector for permits issued by the  
 4 Police Department or Entertainment Commission and, when applicable, for their renewal:

10           Section 2. The fees in Police Code Sections 2.26 and 2.27 amended by this ordinance  
 11 are exempt from the definition of tax under California Constitution Article XIII(C), Section  
 12 1(e)(3).

14           Section 3. Effective Date. This ordinance shall become effective 30 days after  
 15 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the  
 16 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board  
 17 of Supervisors overrides the Mayor's veto of the ordinance.

19           Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors  
 20 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,  
 21 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal  
 22 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment  
 23 additions, and Board amendment deletions in accordance with the "Note" that appears under  
 24 the official title of the ordinance.

1 Section 5. Severability. If any section, subsection, sentence, clause, phrase, or word  
2 of this ordinance, or any application thereof to any person or circumstance, is held to be  
3 invalid or unconstitutional by a decision of a court of competent jurisdiction, such decision  
4 shall not affect the validity of the remaining portions or applications of the ordinance. The  
5 Board of Supervisors hereby declares that it would have passed this ordinance and each and  
6 every section, subsection, sentence, clause, phrase, and word not declared invalid or  
7 unconstitutional without regard to whether any other portion of this ordinance or application  
8 thereof would be subsequently declared invalid or unconstitutional.




