3 **Ordinance amending the Park Code to permit the Recreation and Park Department**
4 **General Manager to impose a surcharge of \$1 per non-resident adult visitor at the**
5 **Japanese Tea Garden to fund the restoration of that facility, until such time as the**
6 **restoration is complete; and affirming the Planning Department's determination under**
7 **the California Environmental Quality Act.**

15 Be it ordained by the People of the City and County of San Francisco:

16 Section 1.

17 The Planning Department has determined that the actions contemplated in this
18 ordinance comply with the California Environmental Quality Act (California Public Resources
19 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of
20 Supervisors in File No. 190630, and is incorporated herein by reference. The Board affirms
21 this determination.

22 Section 2. Article 12 of the Park Code is hereby amended by revising Section 12.05, to
23 read as follows:

24 **SEC. 12.05. JAPANESE TEA GARDEN.**


25 * * * *

1 (f) In addition to the admission fees charged under subsection (a), the Department shall also
2 impose a surcharge of \$1 on each non-resident Adult visitor, for the purpose of funding the restoration
3 of the Pagoda at the Japanese Tea Garden. This subdivision (f) shall expire by operation of law upon
4 completion of the restoration. Upon completion, the General Manager shall inform the City Attorney,
5 who shall then cause this subsection (f) to be removed from the Park Code.

6
7 Section 3. Effective Date. This ordinance shall become effective 30 days after
8 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
9 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
10 of Supervisors overrides the Mayor's veto of the ordinance.

12 Section 4. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
13 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
14 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
15 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
16 additions, and Board amendment deletions in accordance with the "Note" that appears under
17 the official title of the ordinance.
