14 Section 1. Chapter 16, Article V of the Administrative Code is hereby amended by
15 revising Section 16.93, to read as follows:

16 **SEC. 16.93. ORGANIZATIONS FOR WHICH DEDUCTIONS CAN BE MADE.**

17 Deductions and collections as provided by this Article V shall be made for the
18 organizations and the purposes designated in the following ~~subsections~~paragraphs:

20 (o) City and County of San Francisco, for payment to the San Francisco City
21 Services Preservation Fund to reduce the City's deficit and preserve City Services.

22 (p) Firefighters Cancer Prevention Foundation, for the payment of money to.

24 Section 2. Effective Date. This ordinance shall become effective 30 days after
25 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the


