City and County of San <u>Francisco</u>, San Francisco Superior Court, Case No. CGC-15-547492 by the payment of \$240,000 to plaintiffs Joy Caguimbaga and Zenida C. Restauro. The lawsuit involves inverse condemnation arising out of flooding damage during major rainstorms in December of 2014.
