3 **Ordinance amending the Administrative and Planning Codes to establish the South of**  
4 **Market Community Planning Advisory Committee to advise City officials and agencies**  
5 **on implementation of the Central SoMa Plan, Western SoMa Area Plan, and East SoMa**  
6 **Area Plan; and to revise the membership and duties of the SOMA Community**  
7 **Stabilization Fund Community Advisory Committee and the Eastern Neighborhoods**  
8 **Citizens Advisory Committee; and affirming the Planning Department's determination**  
9 **under the California Environmental Quality Act, making findings of consistency with**  
10 **the General Plan, and the eight priority policies of Planning Code, Section 101.1; and**  
11 **making findings of public necessity, convenience, and welfare under Planning Code,**  
12 **Section 302.**

20 Be it ordained by the People of the City and County of San Francisco:

21 Section 1. Environmental and Land Use Findings.

22 (a) The Planning Department has determined that the actions contemplated in this  
23 ordinance comply with the California Environmental Quality Act (California Public Resources  
24 Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of  
25 Supervisors in File No. 181215 and is incorporated herein by reference. The Board affirms  
this determination.

1 (b) On September 19, 2019, the Planning Commission, in Resolution No. 20521,  
2 adopted findings that the actions contemplated in this ordinance are consistent, on balance,  
3 with the City's General Plan and eight priority policies of Planning Code Section 101.1. The  
4 Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk of  
5 the Board of Supervisors in File No. 181215, and is incorporated herein by reference.

6 (c) Pursuant to Planning Code Section 302, the Board of Supervisors finds that these  
7 Planning Code amendments will serve the public necessity, convenience, and welfare for the  
8 reasons set forth in Planning Commission Resolution No. 20521, and the Board incorporates  
9 such reasons herein by reference. A copy of said Resolution is on file with the Clerk of the  
10 Board of Supervisors in File No. 181215, and is incorporated herein by reference.

11  
12  
13 Section 2. Chapter 5 of the Administrative Code is hereby amended by adding Article  
14 XXVI, consisting of Sections 5.26-1, 5.26-2, 5.26-3, 5.26-4, 5.26-5, and 5.26-6, to read as  
15 follows:

16 **ARTICLE XXVI:**

17 **SOUTH OF MARKET COMMUNITY PLANNING ADVISORY COMMITTEE**

18 **SEC. 5.26-1. CREATION OF COMMITTEE.**

19 *The Board of Supervisors hereby establishes the South of Market Community Planning Advisory*  
20 *Committee ("Committee").*

21 **SEC. 5.26-2. MEMBERSHIP AND QUALIFICATIONS.**

22 *(a) The Committee shall consist of 11 voting members. Together, the members of the Committee*  
23 *shall represent the cultural diversity of the East SoMa, Central SoMa, and Western SoMa*  
24 *neighborhoods, and ideally ~~would~~ will include renters of residences in the neighborhoods, resident*  
25 *homeowners in the neighborhoods, low-income residents, local merchants, and representatives of*

1 established neighborhood groups within the East SoMa, Central SoMa, and Western SoMa Plan Areas.  
2 All members shall live, work, or own a business within the boundaries of the East SoMa, Central SoMa,  
3 or Western SoMa Area Plans. When fully constituted, at least three members shall live within the  
4 boundaries of the East SoMa, Central SoMa, or Western SoMa Area Plans.

5 (b) Seats 1, 2, 3, 4, 5, 6, and 7 shall be held by individuals nominated by the District 6  
6 Supervisor and appointed by the Board of Supervisors.

7 (1) Seat 1 shall be held by an individual who has small business expertise.

8 (2) Seat 2 shall be held by an individual with familiarity and experience in infrastructure  
9 and/or safety, as relating to pedestrians, bicyclists, or transit.

10 (3) Seat 3 shall be held by an individual who has familiarity and experience in historic  
11 preservation and/or cultural preservation.

12 (4) Seat 4 shall be held by an individual who has familiarity and experience in  
13 development and/or management of affordable housing.

14 (5) Seat 5 shall be held by an individual who provides direct social services to SoMa  
15 residents.

16 (6) Seats 6 and 7 shall have no additional required qualifications.

17 (c) Seats 8, 9, 10, and 11 shall be held by individuals appointed by the Mayor.

18 (1) Seat 8 shall be held by an individual with a record of advocacy for parks, recreation,  
19 and open space in San Francisco.

20 (2) Seat 9 shall be held by an individual who has expertise in employment development  
21 or represents labor interests.

22 (3) Seats 10 and 11 shall have no additional required qualifications.

23 (d) There shall be 11 alternate members of the Committee, one designated for each of the 11  
24 seats. Alternate members shall be appointed for their respective seats in the same manner prescribed in  
25 subsections (b) and (c). The alternate members of the Committee ~~would~~ ideally will meet the

1 requirements set forth in subsections (b) and (c) for their respective seats, but in any event must  
2 meet the standards set for voting members in subsection (a). An alternate member shall  
3 temporarily serve on the Committee as a voting member when there is a vacancy in the seat, or when  
4 the seat is filled but the member holding the seat is absent from the meeting; the same holds true for  
5 an alternate member temporarily serving on a subcommittee or working group.

6 (e) Each member and each alternate member of the Committee shall serve at the  
7 pleasure of their respective appointing authority and may be removed by their appointing  
8 authority at any time.

9 **SEC. 5.26-3. ORGANIZATION AND TERMS OF OFFICE.**

10 (a) Members of the Committee shall serve three-year terms; provided, however, that the term of  
11 the initial appointees, including alternates, in Seats 1, 2, 7, and 8 shall expire at noon on August 1,  
12 2021; the term of the initial appointees in Seats 3, 4, 9, and 10, including alternates, shall expire at  
13 noon on August 1, 2022; and the term of the initial appointees in Seats 5, 6, and 11, including  
14 alternates, shall expire at noon on August 1, 2023. There shall be no limits on the number of terms a  
15 member may serve on the Committee, as either a voting member or an alternate.

16 (b) Service on the Committee shall be voluntary and members shall receive no compensation  
17 from the City.

18 (c) Any voting member who misses three regular meetings of the Committee within a six-month  
19 period without the express approval of the Committee by majority vote at or before each missed  
20 meeting shall be deemed to have resigned from the Committee 10 days after the third unapproved  
21 absence. The Committee shall inform the Clerk of the Board of Supervisors in the case of a Board  
22 appointee, and the Mayor's Office; in the case of a ~~M~~ayoral appointee, of any such resignation. Any  
23 absence of a voting member of the Committee shall be deemed approved by the Committee, and shall  
24 not count as an unapproved absence, if the alternate member of the Committee designated for the seat  
25 attends a meeting in place of the absent voting member.

1           (d) The Planning Department, in consultation as appropriate with other members of the  
2 Interagency Planning and Implementation Committee described in Chapter 36 of the Administrative  
3 Code as appropriate, shall provide expertise to the Committee as appropriate. The Planning  
4 Department shall provide administrative and clerical support for the Committee.

5           **SEC. 5.26-4. DUTIES.**

6           (a) The general purpose of the Committee shall be to provide input to the Board of Supervisors,  
7 the Mayor, and City agencies regarding the implementation of the Central SoMa Plan, Western SoMa  
8 Area Plan, and East SoMa Area Plan. The City agencies to which the Committee may provide input  
9 include, but are not limited to, the Planning Department, the Mayor's Office of Housing and  
10 Community Development, the Office of Economic and Workforce Development, the Municipal  
11 Transportation Agency, the Recreation and Park Department, the Department of Public Works, the  
12 Arts Commission, and the Interagency Planning and Implementation Committee. The Committee's  
13 prioritization of revenue expenditures described in subsection (b) below that are collected from  
14 development projects in the Central SoMa Plan Area shall be consistent with the Central SoMa  
15 Implementation Program document.

16           (b) The Committee may provide advice regarding the following:

17                   (1) Prioritization of community improvement projects and other public investments  
18 funded by the Central SoMa Infrastructure Impact Fund, established in Planning Code Section 433.4,  
19 including review of any proposed In-Kind Agreements;

20                   (2) Prioritization of community improvement projects and other public investments  
21 related to transit, parks and recreation, complete streets, and environmental sustainability that are  
22 funded by proceeds of the Central SoMa Community Facilities District special tax, as described in  
23 Planning Code Section 434;

24                   (3) Prioritization of community improvement projects and other public investments  
25 funded with Eastern Neighborhoods Impact Fee revenues collected from development projects within

1 East SoMa, Central SoMa, and Western SoMa pursuant to Planning Code Section 423, including  
2 review of any proposed In-Kind Agreements;

3 (4) Proposed revisions or updates to the Central SoMa Implementation Program  
4 Document;

5 (5) Proposed revisions to the sections of the Planning Code or other Codes that are  
6 related to implementation of the Central SoMa Plan, Western SoMa Area Plan, and East SoMa Area  
7 Plan; and

8 (6) Monitoring implementation of the Central SoMa Plan, Western SoMa Area Plan,  
9 and East SoMa Area Plan.

10 (c) The Committee also may provide advice on the following issues regarding development  
11 projects and proposals within the boundaries of the East SoMa Area Plan, Central SoMa Plan, or  
12 Western SoMa Area Plans, or within 0.25 miles of the boundaries of said area plans but outside the  
13 boundaries of the Showplace Square/Potrero Hill, Mission, Central Waterfront, and Market and  
14 Octavia Area Plans:

15 (1) Individual development proposals;

16 (2) Compliance by individual development projects with specific conditions of project  
17 approvals;

18 (3) Design and programming of open spaces, including Privately-Owned Public Open  
19 Spaces (POPOS); and

20 (4) Development proposals for public properties.

21 (d) City agencies may seek input from the Committee on policy matters regarding land use and  
22 zoning changes, capital improvement plans, and other activities that implement the Central SoMa Plan,  
23 Western SoMa Area Plan, and East SoMa Area Plan.

24 (e) The Committee shall collaborate with the Planning Department and relevant city agencies  
25 in monitoring implementation of the Central SoMa Plan, Western SoMa Area Plan, and East SoMa

1 Area Plan at approximately every fifth year, in coordination with the duties required by this Section  
2 5.26-4 and Administrative Code Section 10.E; and provide input to Plan Area monitoring efforts for  
3 required time-series reporting.

4 (f) The Committee shall coordinate with the SoMa Community Stabilization Fund Community  
5 Advisory Committee established in Administrative Code Chapter 5, Article XXVII, when providing  
6 advice on matters within the programmatic jurisdiction of both committees.

7 **SEC. 5.26-5. MEETINGS AND PROCEDURES.**

8 (a) The Board of Supervisors and Mayor shall make initial appointments to the Committee by  
9 no later than three months after the effective date of the ordinance in Board File No. 181215  
10 establishing the Committee. The Committee shall hold its inaugural meeting not more than 30 days  
11 after voting members have been appointed to six seats. There shall be at least 10 days' notice of the  
12 inaugural meeting. Following the inaugural meeting, the Committee shall hold a regular meeting not  
13 less than once every three months until the sunset date set forth in Section 5.26-6.

14 (b) The Committee shall elect its officers and may establish bylaws and rules for its  
15 organization and procedures. The Committee may establish subcommittees or working groups. Each  
16 such subcommittee or working group shall include at least two voting Committee members, but may  
17 also include other individuals selected by the Committee who are not voting members of the Committee.

18 **SEC. 5.26-6. SUNSET.**

19 Unless the Board of Supervisors by ordinance extends the term of the Committee, this Article  
20 XXVI, and hence the Committee, shall expire by operation of law, and the Committee shall terminate,  
21 on January 1, 2035. After that date, the City Attorney shall cause this Article XVI to be removed from  
22 the Administrative Code. Notwithstanding Rule 2.21 of the Board of Supervisors Rules of Order, which  
23 provides that advisory bodies created by the Board should sunset within three years, the Board intends  
24 the Committee to exist for longer than three years.

1 Section 3. Chapter 5 of the Administrative Code is hereby amended by adding Article  
2 XXVII, consisting of Sections 5.27-1, 5.27-2, 5.27-3, 5.27-4, and 5.27-5, to read as follows:

3 **ARTICLE XXVII:**

4 **SOMA COMMUNITY STABILIZATION FUND COMMUNITY ADVISORY COMMITTEE**

5 **SEC. 5.27-1. DUTIES.**

6 (a) The SOMA Community Stabilization Fund Community Advisory Committee ("Committee"),  
7 initially codified at Section 418.7(d) of the Planning Code but now codified in this Article XXVII of the  
8 Administrative Code, shall advise the Mayor's Office of Housing and Community Development  
9 ("MOHCD"), other City agencies, and the Board of Supervisors regarding the following:

10 (1) Administration of the SOMA Community Stabilization Fund described in Section  
11 418.7 of the Planning Code;

12 (2) Prioritization of funding for social services related to cultural preservation that are  
13 funded by proceeds of the Central SoMa Community Facilities District special tax, as defined in  
14 Planning Code Section 434 and the Central SoMa Implementation Program;

15 (3) Prioritization of community improvement projects and other public investments  
16 funded by the Central SoMa Community Services Facilities Fund, established in Planning Code Section  
17 432.4; and

18 (4) Expenditure of affordable housing fees collected pursuant to Planning Code Section  
19 415, and Jobs-Housing Linkage Fees collected pursuant to Planning Code Section 413, generated from  
20 development projects within the boundaries of the East SoMa, Central SoMa, or Western SoMa Area  
21 Plans, or within 0.25 miles of the boundaries of said area plans but outside the boundaries of the  
22 Showplace Square/Potrero Hill, Mission, Central Waterfront, and Market and Octavia Area Plans.

23 (b) The Committee shall collaborate with the Planning Department and relevant city agencies  
24 in monitoring implementation of the Central SoMa Plan, Western SoMa Area Plan, and East SoMa  
25 Area Plan at approximately every fifth year, in coordination with the duties required by this Section

1 5.27-1 and Administrative Code Section Chapter 10.E; and provide input to Plan Area monitoring  
2 efforts for required time-series reporting.

3 (c) The Committee shall develop annual recommendations to MOHCD on the Expenditure Plan  
4 referenced in Section 418.5(d) of this Planning Code.

5 **SEC. 5.27-2. MEMBERSHIP.**

6 (a) The Committee shall be composed of seven voting members appointed by the Board of  
7 Supervisors. The Board of Supervisors shall appoint one alternate member of the Committee for each  
8 of the seats of the seven voting members. An alternate member shall temporarily serve on the  
9 Committee as a voting member when there is a vacancy in the seat or when the seat is filled but the  
10 individual holding the seat is absent from the meeting; the same holds true for an alternate member  
11 temporarily serving on a subcommittee or working group.

12 (b) No fewer than ~~four~~two voting members and ~~four~~two alternate members shall live within the  
13 boundaries of the East SoMa, Central SoMa, or Western SoMa Area Plans. Taken as a whole, the  
14 Committee shall meet the membership requirements set forth below. Taken as a whole, the alternate  
15 members of the Committee would ideally meet these requirements. A single voting member or, for  
16 alternates, a single alternate member, may fulfill more than one of these requirements. Each voting  
17 member and each alternate member shall satisfy at least one of these requirements.

18 (1) One member representing low-income residents of SOMA.

19 (2) One member who has expertise in employment development and/or  
20 represents labor.

21 (3) One member who is a senior or disabled resident of SOMA.

22 (4) One member with affordable housing expertise and familiarity with the  
23 SOMA neighborhood.

24 (5) One member who represents an arts or cultural organization or a cultural  
25 district in SOMA.

1 (6) One member who provides direct services to SOMA residents.

2 (7) One member who has small business expertise and a familiarity with the  
3 SOMA neighborhood.

4 (8) One member who is a youth or who represents a youth-development  
5 organization.

6 (c) Each member and each alternate member of the Committee shall serve at the  
7 pleasure of their appointing authority and may be removed by their appointing authority at any  
8 time.

9 **SEC. 5.27-3. ORGANIZATION AND TERMS OF OFFICE.**

10 (a) The voting members of the Committee shall be appointed for a term of four years. Voting  
11 members may serve no more than two consecutive terms. Service for two or more years of a term  
12 shall be deemed a full four-year term.

13 (b) Annually, the Committee shall select a chair and such other officer or officers as it deems  
14 necessary appropriate.

15 (c) The Committee shall may promulgate such rules or regulations as are necessary or  
16 appropriate for the conduct of its business.

17 (d) In the event a vacancy occurs, a successor shall be appointed by the Board of Supervisors  
18 to fill the vacancy consistent with the requirements of Section 5.27-2. When a vacancy occurs for any  
19 reason other than the expiration of a term of office, the appointee to fill such vacancy shall hold office  
20 for the unexpired term of the appointee's predecessor. Any voting member who misses four meetings  
21 within a twelve-month period, without the approval of the Committee by majority vote, shall be deemed  
22 to have resigned from the Committee. The Committee shall inform the Clerk of the Board of  
23 Supervisors of any such resignation. Any absence of a voting member of the Committee shall be deemed  
24 approved by the Committee, and shall not count as an unapproved absence, if the alternate member of  
25 the Committee designated for the seat attends a meeting in place of the absent voting member.

1                   **SEC. 5.27-4. IMPLEMENTATION AND PROCEDURES.**

2                   ~~(a) The Committee shall be subject to the Conflict of Interest provisions of the City's~~  
3 ~~Charter and Administrative Code.~~

4                   ~~(a)~~ MOHCD shall provide administrative and clerical support to the Committee.

5                   ~~(b)~~ The Committee shall coordinate with the South of Market Community Planning Advisory  
6 Committee established in Administrative Code Chapter 5, Article XXVI, when providing advice on  
7 matters within the programmatic jurisdiction of both committees.

8                   **SEC. 5.27-5. SUNSET.**

9                   Unless the Board of Supervisors by ordinance extends the term of the Committee, this Article  
10 XXVII shall expire by operation of law, and the Committee shall terminate, on January 1, 2035. After  
11 that date, the City Attorney shall cause this Article XXVII to be removed from the Administrative Code.  
12 Notwithstanding Rule 2.21 of the Board of Supervisors Rules of Order, which provides that advisory  
13 bodies created by the Board should sunset within three years, the Board intends the Committee to exist  
14 for longer than three years.

15  
16                   Section 4. Chapter 10E of the Administrative Code is hereby amended by relocating  
17 existing Section 10E.2(d) to Chapter 5 of the Administrative Code, renumbering it as new  
18 Article XXXII, consisting of Sections 5.32-1, 5.32-2, 5.32-3, and 5.32-4, and revising it as  
19 indicated below by additions, deletions, Board amendment additions, and Board amendment  
20 deletions conforming to the "Note" that appears under the official title of ~~the~~this ordinance. The  
21 relocation and consequent renumbering of existing Section 10E.2(d) is~~are~~ made for  
22 codification purposes only, and is~~are~~ not in itself~~themselves~~ intended to change the meaning  
23 of the text.

3                    **SEC. 5.32-1. ESTABLISHMENT AND PURPOSE.**                    ~~(1) — Establishment and Purpose.~~

4                    (a) An Eastern Neighborhoods ~~Community~~Citizens Advisory Committee  
5                    (“Committee”~~AC~~) is hereby established. Within ~~six~~ months of adoption of the Eastern  
6                    Neighborhoods Area Plan and related Planning Code changes, the Mayor and the Board of  
7                    Supervisors shall have appointed all members to the Committee~~AC~~.

8                    (b) The Committee~~AC~~ shall be the central community advisory body charged with  
9                    providing input to City agencies and decision makers with regard to all activities related to  
10                    implementation of three of the Eastern Neighborhoods Area Plans: Showplace Square/Potrero  
11                    Hill, Mission, and Central Waterfront. The Committee~~AC~~ is established for the purposes of  
12                    providing input on the prioritization of Public Benefits funded with revenues collected from  
13                    development projects within the Showplace Square/Potrero Hill, Mission, and Central Waterfront Area  
14                    Plans, updating the Public Benefits program, relaying information to community members in  
15                    each of these three~~four~~ neighborhoods regarding the status of development proposals in these  
16                    three Eastern Neighborhoods Plan Areas, and providing input to Plan Area monitoring efforts  
17                    as appropriate. The Committee~~AC~~ shall be advisory, as appropriate, to the Planning  
18                    Department, the Interagency Planning ~~&and~~ Implementation Committee (~~IPIC~~) described in  
19                    Chapter 36 of the Administrative Code, the Planning Commission, and the Board of Supervisors.

20                    (c) The Committee~~AC~~ may perform the following functions as needed:

21                                    ~~— (1A) Provide written recommendations to~~ Collaborate with the Planning  
22                    Department and the Interagency Planning and Implementation Committee on prioritizing the  
23                    community improvement projects and identifying implementation details as part of the annual  
24                    expenditure program that is adopted by the Board of Supervisors, and request written responses  
25                    to said recommendations from the Interagency Planning and Implementation Committee;

1                    ~~——(2B) Provide an advisory role in a report back process from the Planning~~  
2 ~~Department on enforcement of individual projects' compliance with the Area Plans standards and on~~  
3 ~~specific conditions of project approvals so that those agreements will be more effectively implemented;~~

4                    ~~(C)——~~ Collaborate with the Planning Department and relevant city  
5 agencies in the monitoring of the Showplace Square/Potrero Hill, Mission, and Central Waterfront  
6 Area Plans' implementation program at approximately every fifth year, in coordination with the  
7 Monitoring Program required by ~~the~~ Administrative Code Section Chapter 10.E; and provide  
8 input to Plan Area monitoring efforts for required time-series reporting; and

10 approval of In-Kind Agreements, monitor compliance with the requirements of In-Kind Agreements,  
11 report non-compliance to appropriate City agencies, and request appropriate enforcement of

13                    **SEC. 5.32-2. REPRESENTATION AND APPOINTMENTS.**

15                    ~~——(aA)——~~ The CommitteeAC shall consist of ~~11~~<sup>9</sup> members representing the  
16 diversity of the Eastern Neighborhoods; key stakeholders, including resident renters, resident  
17 homeowners, low-income residents, local merchants, established neighborhood groups within  
18 the Showplace Square/Potrero Hill, Mission, and Central Waterfront Plan Areas; and other groups  
19 identified through refinement of the CommitteeAC process.

20                    ~~——(bB)——~~ All members shall live, work, ~~own property or own a business in~~  
21 the Eastern Neighborhoods Plan Area they are appointed to represent.

24 District boundaries, the District ~~6 and~~ 10 Supervisors shall nominate ~~4~~<sup>four</sup> CommitteeAC  
25 members, the District 9 Supervisor shall nominate two CommitteeAC members, and the District

1 8 Supervisor shall nominate one CommitteeAC member. ~~The appointment of each of the Board's~~  
2 ~~CAC nominees shall be confirmed by the full Board of Supervisors. The seats formerly~~  
3 ~~appointed~~nominated ~~by the District 6 Supervisor shall terminate on the effective date of the~~  
4 ~~ordinance in Board File No. 181215. The terms for all other seats on the Committee appointed by the~~  
5 ~~Board of Supervisors shall continue following the effective date of the ordinance in Board File No.~~

7 ———(dD) The Mayor shall appoint a total of four~~eight~~ members, with one  
8 ~~voting~~ member representing each of the Showplace Square/Potrero Hill, Mission, and Central  
9 Waterfront~~five~~ neighborhoods, and one~~three~~ ~~voting~~ at-large members from any of the Showplace  
10 Square/Potrero Hill, Mission, and Central Waterfront neighborhoods. The seats formerly






