Ordinance amending the Planning Code and the Zoning Map to establish the 430-29th Avenue Special Use District; and affirming the Planning Department's determination under the California Environmental Quality Act; and making findings of consistency with the General Plan and the eight priority policies of Planning Code, Section 101.1. and findings of public necessity, convenience, and welfare under Planning Code, Section 302.

Be it ordained by the People of the City and County of San Francisco:

Section 1. Findings.

(a) The Planning Department has determined that the actions contemplated in this ordinance comply with the California Environmental Quality Act (California Public Resources Code Sections 21000 et seq.). Said determination is on file with the Clerk of the Board of Supervisors in File No. 180776 and is incorporated herein by reference. The Board affirms this determination.

(b) On October 11, 2018, the Planning Commission, in Resolution No. 20309, adopted findings that the actions contemplated in this ordinance are consistent, on balance, with the City's General Plan and eight priority policies of Planning Code Section 101.1. The Board

adopts these findings as its own. A copy of said Resolution is on file with the Clerk of the Board of Supervisors in File No. 180776, and is incorporated herein by reference.

(c) Pursuant to Planning Code Section 302, the Board of Supervisors finds that these Planning Code amendments will serve the public necessity, convenience, and welfare for the reasons set forth in Planning Commission Resolution No. 20309, and the Board incorporates such reasons herein by reference. A copy of said Resolution is on file with the Clerk of the Board of Supervisors in File No. 180776, and is incorporated herein by reference.

Section 2. The Planning Code is hereby amended by adding Section 249.82, to read as follows:

SEC. 249.82. 430 29TH AVENUE SPECIAL USE DISTRICT.

A Special Use District entitled the 430 29th Avenue Special Use District (430 29th Avenue

SUD, or SUD) is hereby established for the purposes set forth in this Section 249.82.

(a) Location. The 430 29th Avenue SUD consists of Assessor's Parcel Block No. 1460, Lot 041. Its boundaries are shown on Special Use District Map SU04 of the Zoning Map.

(b) **Purpose.** The purpose of the 430 29th Avenue SUD is to facilitate the development of uses serving and supporting Social Service and Philanthropic Facilities, which may serve both the immediate neighborhood and the larger San Francisco community in an area with a mix of residential, institutional, and related uses.

(c) Relationship to Other Planning Code Provisions. Applicable provisions of the Planning Code shall apply to the 430 29th Avenue SUD except as otherwise provided in this Section 249.82. In the event of a conflict between other provisions of the Planning Code and this Section 249.82, this Section shall control.
