

1 [Contract Agreement - CDW-Government LLC - Technology Marketplace - Not to  
2 Exceed \$20,000,000]

3 **Resolution authorizing the Office of Contract Administration to enter into**  
4 **contract between the City and County and CDW-Government LLC, for the**  
5 **Technology Marketplace purchases, with an initial not to exceed amount of**  
6 **\$20,000,000 for the term ending December 31, 2021, to commence following**  
7 **Board approval, with two one-year options to extend at the sole and absolute**  
8 **discretion of the City.**

10 WHEREAS, Charter, Section 9.118(b), requires the Board of Supervisors to  
11 approve by Resolution contracts estimated to cost the City \$10,000,000 or more; and

12 WHEREAS, The Office of Contract Administration (“Department”) wishes to  
13 procure Informational Technology products and services on an as-needed basis  
14 through the Technology Marketplace; and

15 WHEREAS, This Agreement was competitively procured as required by San  
16 Francisco Administrative Code Chapter 21.1 through Request for Proposals #99400  
17 “Tiers 1 and 2 of the Technology Marketplace 2.0” a Request for Proposal (“RFP”)  
18 issued on June 20, 2018, in which City selected Contractor as a qualified proposer  
19 pursuant to the RFP; and

20 WHEREAS, The Local Business Entity (“LBE”) subcontracting participation  
21 requirement for this Agreement is 15 % for services, with the exception that the  
22 requirement will be 10% for training services; and

23 WHEREAS, Contractor represents and warrants that it is qualified to perform the  
24 Services required by City as set forth under this Agreement; and

1           WHEREAS, The City's Civil Service Commission approved Contract number  
2 44114-17/18 on July 10, 2018; and

3           WHEREAS, The Office of Contract Administration proposes to award this  
4 contract.

5           WHEREAS, The contract referenced above is substantially in the form attached  
6 and are on file with the Clerk of the Board of Supervisors in File No. 181115, which is  
7 hereby declared to be a part of this Resolution as if set forth fully herein; now,  
8 therefore, be it

9           RESOLVED, That the Board of Supervisors authorizes the Purchaser and  
10 Director of the Office of Contract Administration to execute this contract for the  
11 Technology Marketplace purchases in the amounts described above for the term  
12 ending December 31, 2021, to commence following Board approval, with two options  
13 to extend the contracts for up to one year each at the sole and absolute discretion of  
14 the City; and, be it

15           FURTHER RESOLVED, That within 30 days of the contracts being fully  
16 executed by all parties, the Purchaser and Director of the Office of Contract  
17 Administration shall provide the final contracts to the Clerk of the Board for inclusion  
18 into the official file.


