9 WHEREAS, Upon completion of a competitive selection process, the Airport  
10 Commission adopted Resolution No. 18-0203 on July 10, 2018, awarding the Terminal 1  
11 Retail Concession Lease 1 – Lease No. 18-0203 to InMotion Entertainment Group, LLC; and

12 WHEREAS, The Terminal 1 Retail Concession Lease 1 - Lease No. 18-0203 has a  
13 term of ten years, and an initial minimum annual guarantee of \$405,000; now, therefore, be it

14 RESOLVED, That this Board of Supervisors hereby approves the Terminal 1 Retail  
15 Concession Lease 1 - Lease No. 18-0203, a copy of which is on file with the Clerk of the  
16 Board of Supervisors in File No. 181176; and, be it

17 FURTHER RESOLVED, That within thirty (30) days of the lease being fully-executed by  
18 all parties, the Airport Commission shall provide the final lease to the Clerk of the Board for  
19 inclusion into the official file.


