3 **Resolution determining that the transfer of a Type-21 off-sale general beer, wine,**
4 **and distilled spirits liquor license to Dakhaz, Inc., doing business as Mainland**
5 **Market & Produce, located at 5601 Geary Boulevard (District 1), will serve the**
6 **public convenience or necessity of the City and County of San Francisco, in**
7 **accordance with California Business and Professions Code, Section 23958.4; and**
8 **requesting that the California Department of Alcoholic Beverage Control impose**
9 **conditions on the issuance of the license.**

11 WHEREAS, Dakhaz, Inc., is seeking the transfer of a Type-21 off-sale general
12 beer, wine, and distilled spirits liquor license to do business as Mainland Market &
13 Produce, located at 5601 Geary Boulevard (District 1); and

14 WHEREAS, The Planning Department has verified that the area is properly
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of
17 support with the Department of Alcoholic Beverage Control under California Business
18 and Professions Code, Section 24013, and recommends that the Department of
19 Alcoholic Beverage Control issue the liquor license with a condition; and

20 WHEREAS, The Police Department recommends the following condition:
21 Petitioner(s) shall actively monitor the area under their control in an effort to prevent the
22 loitering of persons on any property adjacent to the licensed premises as depicted on
23 the most recently certified ABC-253; now, therefore, be it

24 RESOLVED, That in accordance with California Business and Professions Code,
25 Section 23958.4, the Board of Supervisors of the City and County of San Francisco

1 hereby determines that the transfer of a Type-21 off-sale general beer, wine, and
2 distilled spirits liquor license to Dakhaz, Inc., doing business as Mainland Market &
3 Produce, located at 5601 Geary Boulevard, will serve the public convenience or
4 necessity of the City and County of San Francisco; and, be it

5 FURTHER RESOLVED, That the Board of Supervisors of the City and County of
6 San Francisco hereby endorses and adopts the recommendation of the Police
7 Department listed above and recommends that the Department of Alcoholic Beverage
8 Control issue the license with those conditions.
