WHEREAS, The Board of Supervisors adopted on July 23, 2019, and the Mayor approved on August 2, 2019, Resolution No. 358-19 authorizing the Director of Property to execute an amended and restated 10-year commercial lease dated June 24, 2019 (the "Restated Lease"), with two five-year extensions, between the City and County of San Francisco ("City" or "Landlord") and Volunteers in Medicine DBA Clinic By the Bay ("Tenant"), with the purpose of rehabilitating adjoining City owned buildings located at 35 and 45 Onondaga Avenue (the "Project") and establishing use of a portion of the Project as a medical clinic, a copy of the Restated Lease is on file with the Clerk of the Board of Supervisors in File No. 190739; and
