16	labor harmony principals, utilizing members of the Directors Guild of America (DGA), the
17	Screen Actors Guild (SAG), and the International Alliance of Theatrical State Employees
18	(IATSE) Local 16; and
19	WHEREAS, The Board of Supervisors finds that the use of the SFPD insignia in the
20	Series will enhance San Francisco's image as a premier location for film and television
21	productions to film and is in the best interests of the City; and
22	WHEREAS, Section 1.101 of the Charter provides that all rights and powers of the City
23	not vested in another officer or entity shall by exercised by the Board of Supervisors, and the
24	Charter does not vest in the SFPD the authority to agree to the use of its insignia in
25	connection with a commercial television production; now, therefore, be it

1	RESOLVED, That the Board of Supervisors hereby authorizes the Chief of Police to
2	agree to let the Producers use the SFPD insignia on uniforms and vehicles in the Series; and,
3	be it
4	FURTHER RESOLVED, That the SFPD insignia shall be used only for the stated
5	purposes, and shall not be used beyond the designations and purposes approved by this
6	Resolution.
