12	WHEREAS, A project to be implemented at San Francisco International Airport (the		
13	"Airport") is eligible for grant assistance under the California Air Resources Board (CARB)		
14	Carl Moyer Memorial Air Quality Standards Attainment Program (the "Carl Moyer Program");

16	WHEREAS, The proposed project is the purchase and installation of charging stations		
17	for electrical ground service equipment (eGSE) and supporting electrical infrastructure (the		
18	"Project"); and		
19	WHEREAS, Serving more Airport gates with eGSE is expected to reduce fossil fuel use		
20	and diesel emissions at the Airport, and new electric charging ports are required to support		
21	increased eGSE use at the Airport; and		
22	WHEREAS, The Carl Moyer Program reimburses up to 50% of the eligible project		
23	costs; and

1	WHEREAS, The Airport Director intends to file a grant application to seek grant
2	assistance under the Carl Moyer Program in an estimated amount up to \$2,746,298 for the
3	Project; and
4	WHEREAS, On January 14, 2020, by Resolution No. 20-0008, the Airport Commission
5	approved the acceptance and expenditure of such grant funds; and
6	WHEREAS, Under Administrative Code, Section 10.170-1, the acceptance and
7	expenditure of federal, state, or other grant funds in the amount of \$100,000 or more is
8	subject to the approval by resolution of the Board of Supervisors; and
9	WHEREAS, Acceptance and expenditure of this grant does not require an Annual
10	Salary Ordinance amendment; and
11	WHEREAS, The Airport Commission proposes to maximize use of available grant
12	funds on program expenditures by not including indirect costs in the grant budget; and
13	WHEREAS, The Planning Department has determined that the Project is categorically
14	exempt from review under the California Environmental Quality Act (California Public
15	Resources Code Sections 21000 et seq.; "CEQA") as a CEQA Guidelines section 15303
16	(Class 3) exemption (Planning Department File No. 2019-003905ENV); said determination is
17	on file with the Clerk of the Board of Supervisors in File No. 200268 and is incorporated herein
18	by reference; the Board affirms this determination; now, therefore, be it

2	Moyer Program grant agreement on behalf of the City; and, be it		
3	FURTHER RESOLVED, That within thirty (30) days of the Grant Agreement being full		
4	executed by all parties, the Airport Commission shall provide a copy to the Clerk of the Boar		
5	of Supervisors for inclusion in the official file.
