

1 [Airport Professional Services Contract - Management and Operation of the Airport's Public  
2 and Employee Parking Facilities - Not to Exceed \$124,812,393]

3 **Resolution retroactively approving Professional Services Contract No. 50107.01 for the**  
4 **Management and Operation of the Airport's Public and Employee Parking Facilities**  
5 **between New South Parking - California, GP, and the City and County of San Francisco,**  
6 **acting by and through its Airport Commission, in an amount not to exceed**  
7 **\$124,812,393 over a five year term from July 1, 2018, through June 30, 2023.**

9 WHEREAS, On June 6, 2017, by Resolution No. 17-0131, the Airport Commission  
10 authorized the issuance of a Request for Proposals (RFP) to select a firm to manage and  
11 operate the Airport's public and employee parking facilities; and

12 WHEREAS, Three proposals were received by the Airport on November 17, 2017, and  
13 Airport staff concluded that all three proposals met the minimum qualifications as set forth in  
14 the RFP; and

15 WHEREAS, A four-person evaluation panel reviewed and scored the written proposals  
16 and oral presentations, and New South Parking - California, GP was the top-ranked firm; and

17 WHEREAS, Staff negotiated a five-year Professional Services Contract for the  
18 Management and Operation of the Airport's Public and Employee Parking Facilities (the  
19 "Contract") with New South Parking - California, GP; and

20 WHEREAS, On April 24, 2018, by Resolution No. 18-0108, the Airport Commission  
21 awarded the Contract to New South Parking - California, GP for a five-year term, commencing  
22 July 1, 2018, through June 30, 2023, in a total amount not to exceed \$124,812,393; and

23 WHEREAS, A copy of the Contract is on file with the Clerk of the Board of Supervisors  
24 in File No. 180441; now, therefore, be it

1           RESOLVED, That the Board of Supervisors hereby approves the Professional Services  
2 Contract No. 50107.01 for the Management and Operation of the Airport's Public and  
3 Employee Parking Facilities between New South Parking - California, GP and the City and  
4 County of San Francisco, acting by and through its Airport Commission, for a five-year term  
5 commencing July 1, 2018, through June 30, 2023 in an amount not to exceed \$124,812,393;

7           FURTHER RESOLVED, That within thirty (30) days of the Contract being fully  
8 executed by all parties, the Airport Commission shall provide the executed Contract to the  
9 Clerk of the Board for inclusion into the official file.
